The referenced SFY 11-12 allocations are available on the Division of Aging and Adult Services website at <http://www.dhhs.state.nc.us/aging/cobudget/fundauthorization.htm>. Please complete, sign, and return the funding format for the Adult Care Home Case Management, Adult Home Specialist Fund, Adult Protective Services SSBG, State In-Home Fund and State Adult Day Care Fund (where applicable) to the attention of Helen Tack, as indicated on the format. The Funding Authorization format is on the website with the SFY 11-12 allocations.

State Adult Day Care SSBG Fund and State In-Home SSBG Fund will be allotted to counties on a quarterly basis. Funding for these programs are largely allocated on the basis of SFY 10-11 county expenditures.

The Adult Care Home Case Management State allocation will continue to be allotted on a quarterly basis.

The Adult Home Specialist State Fund will continue to be allotted on a quarterly basis.

The State Adult Protective Services (APS) funding was eliminated and replaced with SSBG Funds. These funds continue to be allocated on a quarterly basis. See APS funding authorization for additional information.

Daily care rates remain at \$33.07 for Adult Day Care and \$40.00 for Adult Day Health. These rates do not include the \$3.00 daily cost for optional round-trip transportation.
