### **GAC Purpose and Member Introduction**

The GAC works to advise and support assistive technology services provided by NCATP and to make suggestions about expanding AT and related services to all citizens of NC. We are comprised of professionals and AT users across the State.

Members who were absent at the last meeting were introduced as well as our newest members who are Tommy Cloyd, Mark Steele, and Kathleen Wood. Hogan VanSickle and Joshua Barton are two other new members but were not present for today's meeting.

## **GAC Member Presentation -DVR**

# Joy Tribble, DVR

- Recent DHHS Initiatives such as supporting the Olmstead ruling, promoting Employment First, and the creation of a council supporting Diversity, Equity, and Inclusion.
- Factors which influence policy changes include legislation such as the Workforce Innovation and Opportunity Act. It emphasizes competitive employment, career tracks that include training, and Pre-Employment Transition Services. The pandemic also brought about temporary policy changes and adjustments needed to serve individuals.
- DVR is also on-track to receive a new case management system which will allow clients to sign electronically, send messages, and upload documents. The go-live date has been pushed back due to a cyber attack so TBD for that new software.
- DVR is also experiencing a staffing shortage which is impacting service delivery. Currently there is a 32% vacancy rate for Rehabilitation Counselors and 20% overall vacancy rate for all positions.

## AT Expo & Pop Up Events

### Sonya Clark, NCATP

This year's Virtual AT Expo will be from 9:00am to 4:00pm on **September 29<sup>th</sup>**, **2022**. It will include a keynote speaker, 8 sessions, and presentation of the Sallee Awards. There is a scheduled break for lunch and prizes will be given out throughout the day. Sonya has asked for DIY videos or pictures of AT demonstrations to fill in time gaps. See separate attachment. New this year, participants can earn CEU's of .08 for attending the Expo. Thanks for DPI, DVR, DSDHH, EasterSealsUPC, NC AgrAbility, and Annette Lauber for donations of prizes and/or sponsorship of this year's Expo.

Next year, the AT Expo will be sponsored by DPI and will be live in-person at the McKimmon Center in Raleigh on October 5<sup>th</sup>, 2023.

In May, NCATP hosted 3 Aging Resource Fairs or AT Pop-Ups for aging adults and their caregivers along with vendors in Raleigh, Greenville, and Morganton. The purpose is to connect the aging and disabled population with services now and what they might need to stay independent. It was a great success and planning has started for Pop-Ups for 2023 with a focus on adaptable gaming & recreation. The sites have not yet been confirmed so more to come.

# **Stephen E. Sallee Awards**

This award recognizes individuals who support Assistive Technology. There is one award for AT Professionals/Advocate and a separate award for AT user/family/caregiver. ### **ADRC/ACCESS Grants**

# Sarah Gachuz, NCATP

Grants NCATP received under the Cares Act in partnership with DAAS to provide services to individuals who are social isolated, aged, and disabled. NCATP provided assessments and/or consultations to ensure these targeted groups beginning at the end of 2020. Another grant allowed NCATP to purchase AT devices identified during the assessment for these individuals. This was the first time NCATP has purchased equipment directly to individuals as the AT Act does not allow individual purchases.

- 217 individuals have received assessments/consultations and 102 individuals have received devices or are in-process to receive a recommended device.
- Most referrals are from seniors who have vision, hearing, or mobility impairments.
- Currently, we are not taking new grant referrals so we can complete the ones already in process. Both grants end September 30<sup>th</sup>, 2022.

Latrell has been traveling to each of our NCATP centers across the state. NC Council of Developmental Disabilities – Philip Woodward had several announcements

- NCCDD hosted its quarterly meeting in Asheville in May. This was our first in-person quarterly meeting since February 2020.
- NCCDD recently released a Request for Applications (RFA) for Summer Mini-Grants designed to support systems change activities or build capacity to enable individuals with intellectual and developmental disabilities (I/DD) to live full and meaningful lives in the community. Applications were due by June 1st.
- NCCDD presented at the i2i Center for Integrated Health Spring Conference in Raleigh on June 6<sup>th</sup> about unmet needs and how the Direct Support Professionals (DSP) crisis is impacting people with I/DD.
