#### I. <u>INTRODUCTION</u>

North Carolina is experiencing a continual increase in population diversity. Individuals belonging to special populations frequently face distinct challenges and obstacles in locating and accessing culturally competent services that are easily navigable and supportive of their mental health and wellbeing. A coordinated system addressing physical and behavioral health, social determinants, community connectedness and crisis response is critical to meeting the growing needs of all North Carolinians across the lifespan.

The North Carolina Department of Health and Human Services (NC DHHS) Division of Mental Health, Developmental Disabilities, and Substance Use Services (DMHDDSUS) proposes to use Mental Health Block Grant (MHBG) funding to help expand access to relevant services and supports across the state of North Carolina for individuals who are LGBTQAI+, age 65 plus, Faith Communities, or for whom English is not their primary language and any intersections thereof.

#### **ELIGIBILITY**

- 1. Integrated Primary and Behavioral Health Providers, Behavioral Health Practices, Human Service Agencies, Community Organizations, Faith-based Institutions, Faith Communities, Relief Organizations, Advocacy Organizations are eligible to apply.
- 2. Applicants must be a non-profit organization in good standing with the North Carolina Secretary of State's office and if applicant receives over \$750,000 per year from State or Federal funds, must complete a "Yellow Book" audit process each fiscal year satisfactorily. Audit costs can be incorporated into indirect costs which are covered by the project funds.
- 3. Applications must demonstrate a clear understanding of the structural and cultural barriers that exist within the identified special population as well as strategies to improve access and increase engagement and use of mental health services and supports.
- 4. Preference will be given to projects that:
  - o Prioritize the individual within marginalized communities and underserved populations.
  - o Incorporate recognized culturally adapted and trauma-informed practices.
  - Reflect an ability to effectively serve more than one of the identified special populations outlined in this RFA or an enhanced subset of the identified populations.
  - o Leverage peer engagement.
  - Seek to share strengths and knowledge through clear partnerships and work across multiple sectors.
  - o Are designed and implemented by North Carolina based organizations.

#### **FUNDING**

- a) Total Funding Available: \$2,000,000
- b) Awards: Up to ten (10) applicants will be selected for funding, with at least one (1) award for each identified population
- c) Project Budgets up to \$500,000 will be considered. Awardees may be asked to reduce their budgets if multiple projects are selected for funding within the proposed populations and/or funding availability.
- d) Funding Period: December 1, 2024 June 30, 2027; Funding for subsequent years may be available and will be based upon performance and availability of funds.

DMHDDSUS is committed to providing funding for at least 2 years pending availability of funds.

e) Funding Source: Mental Health Block Grant, CFDA Number 93.958, Block Grants for Community Mental Health Services

#### II. <u>BACKGROUND</u>

NC DHHS is dedicated to fostering inclusivity, equality, and empowerment for all individuals, including those within the LGBTQAI+ community, those aged 65 and older, those individuals for whom English is their second language, and Individuals Served by Faith Communities. As part of our commitment to social justice and human rights, we are issuing this Request for Applications (RFA) to solicit applications from organizations and initiatives that aim to support these populations through various programs and activities.

The impact of COVID-19, mass shootings, natural disasters and other traumatic events continues to cause significant trauma for individuals, families and communities across North Carolina. People are reporting increased rates of depression, anxiety, post-traumatic stress and thoughts of self-harm. Some groups have been affected more than others. Individuals with serious mental illness or children with serious emotional disturbance are especially at risk for crisis following these types of events, and historically marginalized communities are less likely to have sufficient access to mental health resources.

The Department of Mental Health, Developmental Disabilities, and Substance Abuse Services (DMHDDSUS) is committed to addressing mental health disparities and promoting equity in access to mental health services. In line with this commitment, we are issuing this RFA to solicit applications for projects focusing on supporting mental health initiatives in underserved communities. Currently, we are targeting four major communities: LGBTQAI+, Older Adults (65+), Individuals whose primary language is not English, and Individuals Served by Faith Communities.

A coordinated system of crisis response and mental health services is critical to meeting the growing needs of North Carolinians. Outreach, training and other resources are needed to ensure that people are connected to culturally and linguistically competent mental health services in their communities.

NOTE: The following narrative will briefly describe each population. NC DHHS DMHDDSUS values innovative and creative approaches to existing problems, we encourage applicants to submit applications/applications that are distinctly linked to their own community and the needs identified by that community.

## ◆ Individuals who identify as LGBTQAI+

The LGBTQAIIA+ community faces significant challenges, including discrimination, stigma, and marginalization, which can have detrimental effects on their well-being and livelihoods. Despite progress in advancing LGBTQAIIA+ rights, there remains much work to be done to ensure full acceptance, equality, and inclusion for all individuals, regardless of their sexual orientation, gender identity, or expression. Through community engagement, capacity building, and education, we aim to build resources that are culturally competent and accessible for all.

#### **◆** Individuals that are Age 65+

Older adults often face various challenges related to mental health, including loneliness, depression, anxiety, grief, and cognitive decline. DHHS recognizes the importance of investing in programs that promote mental health resilience and provide support tailored to the needs of aging or elder communities. DHHS recognizes the importance of addressing mental health needs within aging or elder communities and is committed to supporting initiatives that promote emotional well-being and resilience

among older adults. Through collaborative efforts, we can create supportive environments where older adults can thrive and age with dignity.

## ◆ Individuals with English as a Second Language/Non-Native English Speaking

Individuals whose primary language is not English, often experience a range of stressors and barriers that can impact their mental health, including language barriers, discrimination, social isolation, trauma related to migration experiences, and limited access to culturally competent mental health services. Non-Native English speakers demonstrate a lower utilization of mental health services, often due to a lack of cultural competence and cultural adaptations in systems of care which can result in significant health disparities. Investing in programs and interventions that are culturally and linguistically appropriate can promote resilience and psychological well-being. Approximately 12% of North Carolinians speak languages other than English.

#### **◆** Individuals Served by Faith Communities

Individuals Served by Faith Communities serve as vital spaces where individuals find spiritual guidance, communal support, and a sense of belonging. However, mental health issues are often stigmatized or overlooked within these communities, leading to barriers in accessing appropriate care and support. By integrating mental health awareness, education, and support services into faith-based settings, we can address the holistic needs of individuals and promote well-being for all.

## III. SCOPE OF WORK

NC DHHS DMHDDSUS is issuing this RFA to solicit applications for projects focusing on supporting mental health initiatives in underserved communities. Currently, we are targeting four underserved communities: Older Adults (65+), LGBTQAI+, English as a Second Language (ESL), and Individuals Served by Faith Communities. Applications should aim to address two or more of the following key areas:

- Mental Health and Well-being: Develop and implement programs that provide mental health support, counseling services, and community resources tailored to the specific needs of the target population.
- Increasing Access to Care: Develop strategies to improve access to mental health services in underserved communities, including telehealth services, mobile outreach programs, and partnerships with community-based organizations.
- Culturally Competent Care: Enhance the cultural competence of mental health providers and services to better meet the needs of diverse populations, including training programs, language services, and culturally tailored interventions.
- Addressing Social Determinants of Health: Implement projects that address social
  determinants of mental health, such as housing instability, food insecurity, unemployment, and
  discrimination, through collaborative approaches with community partners.
- Peer Support, Community Engagement, Social Connectivity: Foster peer support networks, community-based support groups, and grassroots initiatives that promote mental health awareness, resilience, and social connectedness in underserved communities. Create opportunities for community engagement.
- o **Prevention and Early Intervention**: Develop prevention and early intervention programs targeting underserved populations to reduce the incidence of mental health disorders, improve early detection, and facilitate timely access to care.
- Training and Capacity Building: Offer training sessions, seminars, and resources to equip leaders and communities with the knowledge and skills to support individuals experiencing mental health issues effectively.
- Creating Safe and Inclusive Spaces: Foster environments within communities that are
  welcoming, inclusive, and safe for individuals to share their mental health concerns, seek
  support, and access resources without fear of judgment or discrimination.
- Collaborative Partnerships: Forge partnerships with mental health organizations, healthcare
  providers, and community resources to enhance access to mental health services and support for
  community members.
- Education and Awareness: Create initiatives to raise awareness, combat stereotypes, and promote understanding of target population issues among the general public, schools, workplaces, faith-based settings, and other institutions.
- o **Community Building and Support Networks**: Establish safe spaces, support groups, and community centers that foster solidarity, belonging, and empowerment of target communities.
- Capacity Building and Training: Provide training, skills development, and capacity-building
  opportunities for underserved communities, organizations, and their leaders to strengthen their
  ability to advocate for improved resources to address the needs of their respective communities.

Intersectional approaches and innovative partnerships are highly encouraged. This list is in no way exhaustive.

#### PERFORMANCE STANDARDS AND EXPECTATIONS

In the application, the entities shall provide:

- 1. A detailed statement of need, a track record of success in projects related to the underserved communities, and an evaluation plan that uses both quantitative and qualitive outcome measures.
- 2. A clear and feasible description of the project design, including the methodology, activities, and anticipated outcomes.
- 3. Proof of capacity and experience of the applicant organization or initiative to successfully implement the proposed project.
- 4. An explanation of potential for sustainability and long-term impact of the project on the target beneficiaries and the broader community.
- 5. A budget justification and cost-effectiveness of the proposed activities.

#### The grantee shall:

- 1. Demonstrate expertise in working with the proposed community.
- 2. Demonstrate active partnership and participation with other organizations by leveraging the diverse strengths of the community.
- 3. Coordinate with other professional and technical services contractors as directed by DMH/DD/SUS.
- Collaborate North Carolina resources for referrals and explore interoperability with organizations such as 211, 988, NC CARE 360, LME/MCO's ADCNC peer line, health departments and other organizations available.
- 5. Enhance and expand knowledge of emerging trends in leadership and management of proposed population(s) and across the state.
- 6. Grantee shall provide DMHDDSUS monthly updates including:
  - a. Progress made on approved project plan, inclusive of your evaluation plan
  - b. FSRs
  - c. Demographic/Geographic data on community engagement and
  - d. Feedback on issues that arise during planning and implementation.

## PERFORMANCE MONITORING/QUALITY ASSURANCE PLAN

Deliverables will be monitored by site visits, monthly data reports and quarterly programmatic reports. The Selected Entity agrees to participate in periodic site visits as needed (with a minimum of one per year) as determined by the Program Manager. If the Selected Entity is deemed out of compliance, program staff will provide technical assistance; and funds may be withheld until Selected Entity is back in compliance with deliverables. If technical assistance does not prove beneficial, the contract may then be terminated.

#### IV. GENERAL INFORMATION ON SUBMITTING APPLICATIONS

## 1. Award or Rejection

All qualified applications will be evaluated, and award made to that agency or organization whose combination of budget and service capabilities are deemed to be in the best interest of the funding agency. The funding agency reserves the unqualified right to reject any or all offers if determined to be in its best interest. Successful applicants will be notified by (09/25/2024).

#### 2. Decline to Offer

Any agency or organization that receives a copy of the RFA but declines to make an offer is requested to send a written "Decline to Offer" to the funding agency. Failure to respond as requested may subject the agency or organization to removal from consideration of future RFAs.

#### 3. Cost of Application Preparation

Any cost incurred by an agency or organization in preparing or submitting an application is the agency's or organization's sole responsibility; the funding agency will not reimburse any agency or organization for any pre-award costs incurred.

## 4. Elaborate Applications

Elaborate applications in the form of brochures or other presentations beyond that necessary to present a complete and effective application are not desired.

## 5. Oral Explanations

The funding agency will not be bound by oral explanations or instructions given at any time during the competitive process or after awarding the grant.

#### 6. Reference to Other Data

Only information that is received in response to this RFA will be evaluated; reference to information previously submitted will not suffice.

#### 7. Titles

Titles and headings in this RFA and any subsequent RFA are for convenience only and shall have no binding force or effect.

#### 8. Form of Application

Each application must be submitted on the form provided by the funding agency and will be incorporated into the funding agency's Performance Agreement (contract).

## 9. Exceptions

All applications are subject to the terms and conditions outlined herein. All responses will be controlled by such terms and conditions. The attachment of other terms and conditions by any agency or organization may be grounds for rejection of that agency or organization's application. Funded agencies and organizations specifically agree to the conditions set forth in the Performance Agreement (contract).

## 10. Advertising

In submitting its application, agencies and organizations agree not to use the results therefrom or as part of any news release or commercial advertising without prior written approval of the funding agency.

#### 11. Right to Submitted Material

All responses, inquiries, or correspondence relating to or in reference to the RFA, and all other reports, charts, displays, schedules, exhibits, and other documentation submitted by the agency or organization will become the property of the funding agency when received.

#### 12. Competitive Offer

Pursuant to the provision of G.S. 143-54, and under penalty of perjury, the signer of any application submitted in response to this RFA thereby certifies that this application has not been arrived at collusively or otherwise in violation of either Federal or North Carolina antitrust laws.

## 13. Agency and Organization's Representative

Each agency or organization shall submit with its application the name, address, and telephone number of the person(s) with authority to bind the agency or organization and answer questions or provide clarification concerning the application.

#### 14. Subcontracting

Agencies and organizations may propose to subcontract portions of work provided that their applications clearly indicate the scope of the work to be subcontracted, and to whom. All information required about the prime grantee is also required for each proposed subcontractor.

Agencies and organizations shall also ensure that subcontractors are not on the state's Suspension of Funding List available at: <a href="http://www.osbm.nc.gov/management/grants">http://www.osbm.nc.gov/management/grants</a>.

#### 15. Proprietary Information

Trade secrets or similar proprietary data which the agency or organization does not wish disclosed to other than personnel involved in the evaluation will be kept confidential to the extent permitted by NCAC TO1: 05B.1501 and G.S. 132-1.3 if identified as follows: Each page shall be identified in boldface at the top and bottom as "CONFIDENTIAL." Any section of the application that is to remain confidential shall also be so marked in boldface on the title page of that section.

#### 16. Participation Encouraged

Pursuant to Article 3 and 3C, Chapter 143 of the North Carolina General Statutes and Executive Order No. 77, the funding agency invites and encourages participation in this RFA by businesses owned by minorities, women and the disabled, including utilization as subcontractor(s) to perform functions under this Request for Applications.

#### 17. Contract

The Division will issue a contract to the recipient of the RFA funding. Expenditures can begin immediately upon receipt of a completely signed contract.

#### V. APPLICATION PROCUREMENT PROCESS AND APPLICATION REVIEW

The following is a general description of the process by which applicants will be selected for funding for this project.

#### 1. Announcement of the Request for Applications (RFA)

The announcement of the RFA and instructions for receiving the RFA will be posted at the following DHHS website on 08/06/2024:

https://www.ncdhhs.gov/about/grant-opportunities/mental-health-developmental-disabilities-and-substance-abuse-services-grant-opportunities and may be sent to prospective agencies and organizations via direct mail, email, and/or the Program's website.

#### 2. Distribution of the RFA

#### 3. Question & Answer Period

Written questions concerning the specifications in this Request for Applications will be received until (08/19/2024). As an addendum to this RFA, a summary of all questions and answers will be e-mailed, by 08/26/2024 to all agencies and organizations sent a copy of this Request for Applications, or will be placed on <a href="https://www.ncdhhs.gov/about/grant-opportunities/mental-health-developmental-disabilities-and-substance-abuse-services-grant-opportunities">https://www.ncdhhs.gov/about/grant-opportunities/mental-health-developmental-disabilities-and-substance-abuse-services-grant-opportunities</a> website.

#### 4. Applications

Applicants shall submit their application as one single, consolidated PDF file with all required attachments and scanned signatures to <a href="mailto:CMHRFAresponses@dhhs.nc.gov">CMHRFAresponses@dhhs.nc.gov</a> AND <a href="mailto:James.Miller@dhhs.nc.gov">James.Miller@dhhs.nc.gov</a>. Paper mailed and faxed applications will not be accepted.

#### 5. Format

The application must be typed on 8.5" x 11" pages with 1" margins. Line spacing should be single-spaced. The font should be Arial and sized 11-point. All pages should be numbered. Use appropriate headings for each section.

#### 6. Space Allowance

Page limits are clearly marked in each section of the application. Refer to VIII.3 Applicant's Response for specifics.

### 7. Application Deadline

All applications must be received by 5:00 pm on **09/06/2024**. Only emailed applications will be accepted (scanned signatures are acceptable). Faxed or mailed applications will not be accepted.

#### 8. Receipt of Applications

Applications from each responding agency or organization will receive an email confirmation if application is received on time.

#### 9. Review of Applications

Applications are reviewed by a multi-disciplinary committee of public and/or private health and human services subject matter experts. Staff from applicant agencies may not participate as reviewers.

Applications will be evaluated by a committee according to completeness, content, experience with similar projects, ability of the agency's or organization's staff, cost, etc. The State reserves the right to conduct site visits as part of the application review and award process. The award of a grant to one agency and organization does not mean that the other applications lacked merit, but that, all facts considered, the selected application was deemed to provide the best service to the State. Agencies and organizations are cautioned that this is a request for applications, and the funding agency reserves the unqualified right to reject any and all applications when such rejections are deemed to be in the best interest of the funding agency.

#### 10. Request for Additional Information

At their option, the application reviewers may request additional information from any or all applicants for the purpose of clarification or to amplify the materials presented in any part of the application. However, agencies and organizations are cautioned that the reviewers are not required to request clarification. Therefore, all applications should be complete and reflect the most favorable terms available from the agency or organization.

## 11. Audit

Please be advised that successful applicants may be required to have an audit in accordance with G.S. 143C-6-22 and G.S. 143C-6-23 as applicable to the agency's status.

G.S. 143C-6-23 requires every nongovernmental entity that receives State or Federal pass-through grant funds directly from a State agency to file annual reports on how those grant funds were used.

There are 3 reporting levels which are determined by the total direct grant receipts from all State agencies in the entity's fiscal year:

Level 1: Less than \$25,000

Level 2: At least \$25,000 but less than \$500,000

Level 3: \$500,000 or more

Level 3 grantees are required to submit a "Yellow Book" Audit done by a CPA. Only Level 3 grantees may include audit expenses in the budget. Audit expenses should be prorated based on the ratio of the grant to the total pass-through funds received by the entity.

#### 12. Assurances

The contract may include assurances that the successful applicant would be required to execute prior to receiving a contract as well as when signing the contract.

## 13. Additional Documentation to Include with Application

All applicants are required to include documentation of their tax identification number.

Those applicants which are private non-profit agencies are to include a copy of an IRS determination letter regarding the agency's 501(c)(3) tax-exempt status. (This letter normally includes the agency's tax identification number, so it would also satisfy that documentation requirement.)

In addition, those private non-profit agencies are to provide a completed and signed page verifying continued existence of the agency's 501(c)(3) status. (An example of this page is provided in section *VIII.8 Verification of* 501(c)(3) *Status*.)

#### 14. Federal Certifications

Agencies or organizations receiving Federal funds would be required to execute Federal Certifications regarding Non-discrimination, Drug-Free Workplace, Environmental Tobacco Smoke, Debarment, Lobbying, and Lobbying Activities. A copy of the Federal Certifications is included in this RFA for your reference (see Appendix A). Federal Certifications should NOT be signed or returned with application.

## 15. Unique Entity Identifier (UEI)

All grantees receiving federal funds must have a Unique Entity Identifier (UEI) which is issued by the federal government in <a href="www.SAM.gov">www.SAM.gov</a> . If your agency does not have a UEI, please use the online registration at <a href="www.SAM.gov">www.SAM.gov</a> to receive one free of charge.

#### 16. Additional Documentation Prior to Contract Execution

Contracts require more documentation <u>prior to</u> contract execution. After the award announcement, <u>agencies will be contacted</u> about providing the following documentation:

a. Documentation of the agency's Unique Entity Identifier (UEI). Documentation consists of a copy the agency or organization's SAM record.

If your agency does not have a UEI, please use the online registration at <a href="www.SAM.gov">www.SAM.gov</a> to receive one free of charge.

Contracts with private non-profit agencies require additional documentation <u>prior to</u> contract execution. After the award announcement, private non-profit <u>agencies will be contacted</u> about providing the following documentation:

- a. A completed and signed statement which includes the agency's Conflict of Interest Policy. (A reference version appears in Appendix A.)
- b. A completed, signed, and notarized page certifying that the agency has no overdue tax debts. (A reference version appears in Appendix A)

All grantees receiving funds through the State of North Carolina are required to execute Contractor Certifications Required by North Carolina Law. A copy of the certifications is included in this RFA for your reference (see Appendix A). Contractor Certifications should NOT be signed or returned with application.

Note: At the start of each calendar year, all agencies with current DMH/DD/SUS contracts are required to update their contract documentation. These agencies will be contacted a few weeks prior to the due date and will be provided the necessary forms and instructions.

#### 17. Registration with Secretary of State

Private non-profit applicants must also be registered with the North Carolina Secretary of State to do business in North Carolina or be willing to complete the registration process in conjunction with the execution of the contract documents. (Refer to: <a href="https://www.sosnc.gov/divisions/business\_registration">https://www.sosnc.gov/divisions/business\_registration</a>)

## 18. Registration in NC e-Procurement via NC Electronic Vendor Portal (eVP)

Successful applicants must be registered in NC eProcurement via the Electronic Vendor Portal (eVP) in order to receive reimbursement payments. This registration does not change your organization's subrecipient status or how the organization will be treated by DMHDDSUS.

## 19. Federal Funding Accountability and Transparency Act (FFATA) Data Reporting Requirement

The Contractor shall complete and submit to the Division, the Federal Funding Accountability and Transparency Act (FFATA) Data Reporting Requirement form within 10 State Business Days upon request by the Division when awarded \$25,000 or more in federal funds. A reference version appears in Appendix A.

#### 20. Sudan Divestment Act

The Sudan (Darfur) Divestment Act of 2007, as amended, requires State agencies to divest from investments in companies that are engaged in certain activities in Sudan. Any organization identified engaging in investment activities in Sudan (Darfur), as determined by appearing on the Final Divestment List created by the NC Department of the State Treasurer, is ineligible to contract with the State of North Carolina or any political subdivision of the State. Refer to NC General Statutes Chapter 147 Article 6D.

#### 21. Iran Divestment Act

The Iran Divestment Act of 2015, as amended, prohibits State agencies from investing in or contracting with individuals and companies engaged in certain investment activities in Iran. Any organization identified engaging in investment activities in Iran, as determined by appearing on the Final Divestment List created by the NC Department of the State Treasurer, is ineligible to contract with the State of North Carolina or any political subdivision of the State. Refer to NC General Statutes Chapter 147 Article 6E.

## 22. Boycott Israel Divestment Policy

The Divestments from Companies Boycotting Israel Act of 2017, as amended, prohibits State agencies from making investments in, and contracts with, companies that are engaged in a boycott of Israel, as defined by this Act. Any organization that boycotts Israel, as determined

by appearing on the Final Divestment List created by the NC Department of the State Treasurer, is ineligible to contract with the State of North Carolina or any political subdivision of the State. Refer to NC General Statutes Chapter 147 Article 6G.

#### VI. PROJECT BUDGET

#### **Budget and Justification**

Applicants must submit a budget, which requires a line-item budget for each year of funding and a narrative justification.

#### **Narrative Justification for Expenses**

A narrative justification must be included for every expense listed in the budget. Each justification should show how the amount on the line-item budget was calculated, and it should be clear how the expense relates to the project.

#### **Travel Reimbursement Rates**

Mileage reimbursement rates must be based on rates determined by the North Carolina Office of State Budget and Management (OSBM). Because mileage rates fluctuate with the price of fuel, the OSBM will release the "Change in IRS Mileage Rate" memorandum to be found on OSBM's website when there is a change in this rate. The current state mileage reimbursement rate is 0.67 cents per mile.

For other travel related expenses, please refer to the current rates for travel and lodging reimbursement, presented in the chart below. However, please be advised that reimbursement rates periodically change. The Division of Mental Health, Developmental Disabilities and Substance Use Services will only reimburse for rates authorized in OSBM's North Carolina Budget Manual or adopted by means of an OSBM Budget Memo. ## **Other Restrictions (if applicable)**

#### **Audits**

G.S. 143C-6-23 requires every nongovernmental entity that receives State or Federal pass-through grant funds directly from a State agency to file annual reports on how those grant funds were used. There are 3 reporting levels that are determined by the total direct grant receipts from all State agencies

in the entity's fiscal year: Level 1: Less than \$25,000

Level 2: At least \$25,000 but less than \$750,000

Level 3: \$750,000 or more

Level 3 grantees are required to submit an audit. Only Level 3 grantees may include audit expenses in the budget. Audit expenses should be prorated based on the ratio of the grant to the total pass-through funds received by the entity.

#### **Indirect Cost**

Indirect cost is the cost incurred for common or joint objectives which cannot be readily identified but are necessary to the operations of the organization, e.g., the cost of operating and maintaining facilities, depreciation, and administrative salaries. Regulations restricting the allocation of indirect cost vary based on the funding source.

Per NC Session Law 2023-65: For Grantees, including nonprofit grantees, that (i) are receiving financial assistance and do not have a federally approved indirect cost rate from a federal agency or (ii) have a previously negotiated but expired rate, the Department may allow the grantee, in accordance with 2 C.F.R. § 200.332(a)(4) or 2 C.F.R. § 200.414(f), to use the de minimis rate of modified total direct costs. Alternatively, the grantee may negotiate or waive an indirect cost rate with the Department. If State or federal law or regulations establish a limitation on the amount of funds the grantee may use for administrative purposes, then that limitation controls, in accordance with 2 C.F.R. § 200.414(c)(3).

This RFA is funded by Mental Health Block Grant funds.

## Federal MHBG (with Indirect Cost/Administrative Restrictions)

Indirect costs are allowed on the portion of the sub-award funded by the Community Based Behavioral Health Initiatives – LGBTQAIAI+, English as a Second Language, Faith Communities, and Older Adults.

The Community Based Behavioral Health Initiatives – LGBTQAIAI+, English as a Second Language, Faith Communities, and Older Adults award limits administrative cost to 40 percent.

Where the applicant has a Federal Negotiated Indirect Cost Rate (FNICR), the indirect cost rate requested may not exceed the award's limit as defined above regardless of the applicant's recognized rate. The total modified direct cost identified in the applicant's FNICR shall be applied. A copy of the FNICR must be included with the applicant's budget.

If the applicant does not have an FNICR, then the applicant may claim indirect cost up to the limit as defined above or the de minimus indirect cost rate of 10%, whichever is less with no additional documentation required, per the federal Uniform Guidance. The applicant may elect to claim a lesser portion of the allowed indirect cost rate. If claiming the de minimus or some portion thereof, it may not exceed the limit of the modified total direct costs in the proposed budget as defined by 2 CFR 200.1 "Modified Total Direct Cost (MTDC)". Applicants must indicate in the budget narrative that they wish to use the de minimis rate, or some part thereof. Applicants who do not wish to claim any indirect cost must enter "No indirect cost requested" in the indirect cost line item of the budget narrative.

#### **EVALUATION CRITERIA**

As NC DHHS DMHDDSUS strives for transparency and equity in the RFA process, we recognize that all applicants would benefit from seeing how their application will be evaluated. Below is the process we will take on these applications. It is broken into two phases: Qualifying and Scoring. Any application that does not pass Phase I will not continue to Phase II and be disqualified from consideration.

- g. Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f).

#### **Conflict of Interest Policy Example**

The Board of Directors/Trustees or other governing persons, officers, employees or agents are to avoid any conflict of interest, even the appearance of a conflict of interest. The Organization's Board of Directors, Trustees, or other governing body, officers, staff and agents are obligated to always act in the best interest of the organization. This obligation requires that any Board member or other governing person, officer, employee or agent, in the performance of Organization duties, seek only the furtherance of the Organization mission. If a Board or other governing body member, officer, employee or agent is acting in any official capacity, honoraria received in connection with activities relating to the Organization are to be paid to the Organization.
- C. No Board member or other governing person, officer, employee, or agent of the Organization shall participate in the selection, award, or administration of a purchase or contract with a vendor where, to his knowledge, any of the following has a financial interest in that purchase or contract:
