Due to SSBG reductions in Session Law 2013-360 (Senate Bill 402) ratified by the General Assembly on July 25, 2013 and signed by Governor McCrory on July 26, 2013, SSBG funding was reduced for the State Adult Day Care Fund and State In-Home Fund by approximately 7.5%. The full reduction is realized in the State In-Home Fund. The reduction in State Adult Day Care Fund is mitigated by continuing the state appropriation and shows a 4% decrease in resources going to counties.

The 52 agencies which receive the SSBG APS funds will notice a decrease in funds of approximately 7.5% as compared with last year's allocation as a result of the reductions in the SSBG Spending Plan.

Funding levels for the Adult Home Specialist Fund remain the same from the previous year.

Funding for Adult Care Home Case Management Services was terminated as of June 30, 2013.
