## **1.0 INTRODUCTION**

### **1.1 BACKGROUND**

The COVID-19 pandemic remains a constant in the North Carolina environment with many having limited access to testing and/or mitigation strategies.

People with mental illness and substance use disorders are more likely to have co-morbid physical health issues, and have a higher instance of contracting COVID-19, as well as higher risk of death or a poor outcome from an episode of COVID-19. To address this concern, SAMHSA will invest funding to expand dedicated testing and mitigation resources for people with mental health and substance use disorders.

These funds will provide resources and flexibility for the state to prevent, prepare for, and respond to the COVID-19 public health emergency and ensure the continuity of services. Targeted support is necessary for mental health and substance use treatment providers to overcome barriers towards achieving and maintaining high COVID-19 testing rates. These barriers include limited financial and personal resources to support ongoing testing efforts, hesitancy in accepting vaccines, and challenges with health care access.

NC Division of MH/DD/SAS is promoting the accessibility of testing and mitigation strategies for children, families, and adults in congregate or residential settings utilizing COVID Mitigating Funding from Community Mental Health and Substance Abuse Prevention and Treatment Block Grants. DMHDDSAS is seeking up to six (6) providers to implement COVID-19 mitigation strategies and resources.

#### **SUD Activities:**

- 1) Develop and implement strategies to address consumer hesitancy around testing. Ensure access for specific community populations to address long standing systematic health and social inequities that have put some consumers at increased risk of getting COVID-19 or having severe illness. Provide support for utilization of space/staffing to address COVID mitigation.
- 2) Testing for staff and consumers in shelters, group homes, residential treatment facilities, day programs, and room and board programs. Purchase of resources for testing related operating and administrative costs otherwise borne by these programs. Hire workers to coordinate resources, develop strategies and support existing community partners to prevent infectious disease transmission in these settings. Use the funding to procure COVID-19 tests and other mitigation supplies such as hand washing stations, hand sanitizer, and masks for people experiencing homelessness and for those living in congregate settings.

#### **MH Activities:**

- 1) Testing for staff and consumers in shelters, group homes, residential treatment facilities, day programs, and room and board programs. Purchase of resources for testing related operating and administrative costs otherwise borne by these programs. Hire workers to coordinate resources, develop strategies and support existing community partners to prevent infectious disease transmission in these settings. Use the funding to procure COVID-19 tests and other mitigation supplies such as hand washing stations, hand sanitizer, and masks for people experiencing homelessness and for those living in congregate settings
- 2) Installing temporary structures, leasing of properties, and retrofitting facilities as necessary to support COVID-19 testing and mitigation.
- 3) Create space for quarantine and other COVID-19 mitigation strategies by utilizing funds to support staffing/space allocation for units specific to either COVID or non-COVID areas for behavioral health patients.

## 2.0 **ELIGIBILITY**

### MH Eligibility:

Eligible applicants are not-for-profit or Tribal entities with experience serving the SMI and/or SED populations

And

Either congregate care, and/or residential provider agencies, and/or day programs for children, families and/or adults

Or

Agencies interested in or having experience serving rural, marginalized and/or traditionally under-served communities.

### SU Eligibility:

Eligible applicants are not-for profit or Tribal entities with experience and certification for serving the Substance Use population

And

Either congregate care, and/or residential provider agencies, and/or day programs for children, families and/or adults

Or

Agencies interested in or having experience serving rural, marginalized and/or traditionally under-served communities.

## 3.0 **AWARD INFORMATION**

### A. Funding methodology:

- Block Grants for Community Mental Health Services and Substance Abuse Prevention and Treatment.

### B. Estimated # of MH Awardees:

- Up to six (6) organizations will be selected, three (3) for congregate care and/or residential provider agencies for children, families and/or adults and three (3) for agencies interested in or having experience serving rural, marginalized and/or traditionally under-served communities

### Estimated # of SU Awardees:

- Up to six (6) organizations will be selected, three (3) for congregate care and/or residential provider agencies for children, families and/or adults and three (3) for agencies interested in or having experience serving rural, marginalized and/or traditionally under-served communities

### C. Estimated Amount per organization:

#### MH Funding:

- \$230,845 for congregate care and/or residential provider and/or day program agencies for children, families and/or adults.
- \$221,179 for agencies interested in or having experience serving rural, marginalized and/or traditionally under-served communities

#### SU Funding:

- \$218,547 for congregate care and or residential provider, and/or day program agencies for children, families and/or adults
- \$209,976 for agencies interested in or having experience serving rural, marginalized and/or traditionally under-served communities

### D. Indirect Cost:

- The selected organization may request up to 10% in indirect costs to cover administrative functions unless the applicant has an approved indirect cost allocation plan. These costs are included as part of the overall award amount. The applicant must submit the approved indirect cost allocation plan with their application

### E. Limitations and Restrictions:

- Funding period ends 9/30/2025

### F. Allowable Costs:

- Allowable and appropriate costs must be reasonable and necessary to provide the services. Funding may be used for start-up costs and for ongoing operational costs related to direct provision of services on a cost reimbursement basis. A Financial Status Report (FSR) must be submitted for the start-up costs upon execution of the contract. Once the costs are incurred, the backup documentation shall be submitted to DMH/DD/SAS for review of allowable costs and approval. Any unallowable costs shall be reimbursed by the contractor to DMH/DD/SAS

## **5.0 SCOPE OF WORK**

### **5.1 PROGRAMMATIC REQUIREMENTS AND PRIORITIES**

The primary intent of this RFA is to provide COVID Mitigation funding for rural and underserved marginalized communities through SABG, and congregate care and/or residential provider agencies for children, families and/or adults through CMHBG to increase comfortability and accessibility for COVID testing, as well as provide information on vaccines to increase vaccination rates.

The following activities are permitted under the terms of the funding:

1. Installation of temporary structures to support COVID-19 testing and mitigation
2. Leasing of property to support COVID-19 testing and mitigation
3. Retrofitting facilities as necessary to support COVID-19 testing and mitigation
4. Utilization of funds to support staffing for units specific to either COVID-19 or non-COVID-19 space for behavioral health consumers
5. Utilization of funds to support space allocation for units specific to either COVID-19 or non-COVID-19 space for behavioral health consumers
6. Ensure access for specific community populations to address long-standing systemic health and social inequities that have put some consumers at increased risk of getting COVID-19 or having severe illness.

The following activities are not permissible under the terms of the funding:

1. The installation of permanent structures
2. Space and/or staffing for non-behavioral health consumers
3. Utilization of these funds for the purchase of vaccine

#### **Responsibilities of Provider:**

1. Provide a detailed budget and scope of work to increase accessibility of testing and mitigation strategies to consumers within their congregate or residential settings.
2. Implement the scope of work and expend all funding by 9/30/25
3. Provide monthly status and progress reports to the contract administrator
4. Meet monthly with contract administrator to address barriers, progress and timelines
5. Provide quarterly progress reports which will include the following:
  - a. Progress towards meeting the scope of work deliverables
  - b. Number and location of consumers, including age, gender, race/ethnicity, and staff tested and results
  - c. Number of consumers and staff who benefited from COVID mitigation strategies
  - d. Number of known COVID cases
  - e. Number of COVID test administered
  - f. Number of staff hired to prevent disease transmission in setting
  - g. Inventory of resources/supplies purchased
  - h.
  - i.
  - j. Barriers
  - k. Plan to address barriers

## **5.2 PERFORMANCE STANDARDS AND EXPECTATIONS**

The Contractor is expected to ensure the following:

- a. All equipment purchases to adhere to CDC guidelines
- b. All testing supplies to adhere to CDC guidelines
- c. All testing protocols to adhere to CDC guidelines
- d. Any temporary structures and/or leasing of space to adhere to CDC guidelines with respect to COVID mitigation strategies.

## **5.3 REPORTING REQUIREMENTS**

The Contractor is expected to submit a quarterly progress report documenting the following:

- a. Progress towards completion of deliverables
- b. Barriers towards completion of deliverables
- c. Expenditures to date
- d. Number of consumers served by grant funded equipment/resources/strategies
- e. Penetration rate based on estimated number of unvaccinated individuals
- f. Number of individuals provided COVID testing through this grant by gender, age, race/ethnicity
- g. Number of individuals provided information and resources specific to the COVID vaccine and vaccination
- h. Additional reporting requirements may be determined upon award of the funds.
- i. The successful applicant will be required to submit a monthly Financial Status Report (FSR), detailed in Section 9.0 of this RFA.

## **5.4 CONTRACTOR QUALIFICATIONS AND CAPACITY**

The Contractor must fulfill the following qualifications:

- a. Have sufficient financial stability to cover the organization for up to 90 days before being reimbursed by DMH/DD/SAS
- b. Awardees must have internal controls in place and use generally accepted accounting principles (GAAP).
- c. Non-profit organization or tribal entities

And

- For CMHBG:
  - d. Be licensed as a residential and/or congregate care, and/or day program setting for children, families, or adults with SMI or SED (this can include, but not limited to, Psychiatric Residential Treatment Facilities; Level III or IV Group Homes, Homeless Shelters)
- For SABG:
  - a. Have a proven track record of collaboration with community partners to better assure sufficient resources are available to individuals to meet treatment and recovery needs.

## **6.0 PERFORMANCE OVERSIGHT**

DMH/DD/SAS will:

- Provide technical assistance as requested by the contractor
- Ensure funds are assigned to eligible expenditures
- Monitor the performance of selected applicants and the outcomes of these projects.

## **7.0 TERM OF CONTRACT, OPTIONS TO EXTEND**

The performance period for this contract begins 9/01/2022 (or upon execution) and ends 9/30/2025. Up to one possible option year may be exercised by mutual agreement in accordance with the Terms and Conditions.

## **8.0 BUDGET**

The RFA/ line item budget shall constitute the total cost to the Division for complete performance in accordance with the requirements and specifications herein, including all applicable expenses such as administrative cost. Contractor shall not invoice for any amounts not specifically allowed for in the line item budget of this RFA.

The Contractor shall use the Cost Table found in ATTACHMENT A: Line Item Budget to create the Line Item Budget and Budget Narrative. The Vendor shall not use any other tables or forms, nor modify the contents of any of the shaded cells in the Cost Table.

All costs provided in Line item budget must be firm and fixed for the duration of the contract, which could last as long as three years if the State exercises its option for one additional year.

## **9.0 INVOICING AND REIMBURSEMENT**

Upon execution of this contract, the Contractor shall submit to the Division Contract Administrator, a monthly reimbursement request for services rendered the previous month by the 10th of each month and, upon approval by the Division, receive payment within 30 days. Monthly payment shall be made based on actual expenditures made in accordance with the approved budget on file with both parties and reported on the monthly expenditure report submitted by the Contractor. If this contract is terminated, the Contractor shall complete a final accounting report and return any unearned funds to the Division within 30 days of the contract termination date. The Division shall have no obligation for payments based on expenditure reports submitted later than 30 days after termination or expiration of the contract period. All payments are contingent upon fund availability.

## **10.0 THE SOLICITATION PROCESS**

The following is a general description of the process by which agencies or organizations will be selected to complete the goal or objective.

- 1) RFAs are being sent to prospective agencies and organizations.
- 2) Written questions concerning the RFA specifications will be received until the date specified on the cover sheet of this RFA. A summary of all questions and answers will be posted on the RFA web site.
- 3) Applications will be received from each agency or organization. The original must be signed and dated by an official authorized to bind the agency or organization.
- 4) All applications must be received by the funding agency not later than the date and time specified on the cover sheet of the RFA. Faxed applications will not be accepted.
- 5) At that date and time, the applications from each responding agency and organization will be logged in.
- 6) At their option, the evaluators may request additional information from any or all Contractors for the purpose of clarification or to amplify the materials presented in any part of the application. However, agencies and organizations are cautioned that the evaluators are not required to request clarification: therefore, all applications should be complete and reflect the most favorable terms available from the agency or organization.
- 7) Applications will be evaluated according to completeness, content, experience with similar projects, ability of the agency's or organization's staff, cost, etc. The award of a grant to one agency and organization does not mean that the other applications lacked merit, but that, all facts considered, the selected application was deemed to provide the best service to the State.



- 8) Agencies and organizations are cautioned that this is a request for applications, and the funding agency reserves the unqualified right to reject any and all applications when such rejections are deemed to be in the best interest of the funding agency.

## **11.0 GENERAL INFORMATION ON SUBMITTING APPLICATIONS**

- 1) Award or Rejection  
All qualified applications will be evaluated, and awards made to those agencies or organizations whose capabilities are deemed to be in the best interest of the funding agency. The funding agency reserves the unqualified right to reject any or all offers if determined to be in its best interest. Successful Contractors will be notified by August 16, 2022.
- 2) Decline to Offer  
Any agency or organization that receives a copy of the RFA but declines to make an offer is requested to send a written "Decline to Offer" to the funding agency. Failure to respond as requested may subject the agency or organization to removal from consideration of future RFAs.
- 3) Cost of Application Preparation  
Any cost incurred by an agency or organization in preparing or submitting an application is the agency's or organization's sole responsibility; the funding agency will not reimburse any agency or organization for any pre-award costs incurred.
- 4) Elaborate Applications  
Elaborate applications in the form of brochures or other presentations beyond that necessary to present a complete and effective application are not desired.
- 5) Oral Explanations  
The funding agency will not be bound by oral explanations or instructions given at any time during the competitive process or after awarding the grant.
- 6) Reference to Other Data  
Only information that is received in response to this RFA will be evaluated; reference to information previously submitted will not suffice.
- 7) Titles  
Titles and headings in this RFA and any subsequent RFA are for convenience only and shall have no binding force or effect.
- 8) Form of Application  
Each application must be submitted on the form provided by the funding agency, which will become the funding agency's Performance Agreement (contract).
- 9) Exceptions  
All applications are subject to the terms and conditions outlined herein. All responses will be controlled by such terms and conditions. The attachment of other terms and condition by any agency and organization may be grounds for rejection of that agency or organization's application. Funded agencies and organizations specifically agree to the conditions set forth in the Performance Agreement (contract).
- 10) Advertising  
In submitting its application, agencies and organizations agree not to use the results therefrom or as part of any news release or commercial advertising without prior written approval of the funding agency.
- 11) Right to Submitted Material  
All responses, inquiries, or correspondence relating to or in reference to the RFA, and all other reports, charts, displays, schedules, exhibits, and other documentation submitted by the agency or organization will become the property of the funding agency when received.
- 12) Competitive Offer  
Pursuant to the provision of G.S. 143-54, and under penalty of perjury, the signer of any application submitted in response to this RFA thereby certifies that this application has not been arrived at collusively or otherwise in violation of either Federal or North Carolina antitrust laws.
- 13) Agency and Organization's Representative  
Each agency or organization shall submit with its application the name, address, and telephone

number of the person(s) with authority to bind the agency or organization and answer questions or provide clarification concerning the application.

**14) Subcontracting**

Agencies and organizations may propose to subcontract portions of work provided that their applications clearly indicate the scope of the work to be subcontracted, and to whom. All information required about the prime grantee is also required for each proposed subcontractor. **A subcontractor contract template must be submitted with the contractor's application. All subcontractors must be approved prior to use by the contractor.**

**15) Proprietary Information**

Trade secrets or similar proprietary data which the agency or organization does not wish disclosed to other than personnel involved in the evaluation will be kept confidential to the extent permitted by NCAC TO1: 05B.1501 and G.S. 132-1.3 if identified as follows: Each page shall be identified in boldface at the top and bottom as "CONFIDENTIAL." Any section of the application that is to remain confidential shall also be so marked in boldface on the title page of that section.

**16) Participation Encouraged**

Pursuant to Article 3 and 3C, Chapter 143 of the North Carolina General Statutes and Executive Order No. 77, the funding agency invites and encourages participation in this RFA by businesses owned by minorities, women and the disabled including utilization as subcontractor(s) to perform functions under this Request for Applications.

**17) Contract**

The Division will issue a contract to the recipient of the grant that will include their application.

**18) Federal Certifications**

- i) Agencies or organizations receiving Federal funds will be required to execute Federal Certifications regarding Non-discrimination, Drug-Free Workplace, Environmental Tobacco Smoke, Debarment, Lobbying, and Lobbying Activities. A copy of the Federal Certifications is included in this RFA for your reference (see Appendix B). Federal Certifications should be signed or returned with the application.

**19) Insurance**

**Proof of minimum insurance requirements is required for the contractor and all subcontractors upon award.**

Please be advised that successful Contractors may be required to have an audit in accordance with G. S. 143-6.2 as applicable to the agency or organization's status. Also, the contract may include assurances the successful Contractor would be required to execute when signing the contract. Agencies or organizations receiving Federal funds will be required to execute a Consolidated Federal Certification form (as applicable). Private not for profit agency contracts will also include a conflict of interest policy statement.

## **12.0 APPLICATION CONTENT AND INSTRUCTIONS**

This section includes what the Contractor is required to provide the division with its application response. *The Contractor must clearly demonstrate (describe) in its proposal response* how the Contractor's Organization will meet or address the programmatic requirements described in the scope of work section of the RFA. The Contractor proposal shall include the following items in this specific order and clearly marked as such.

Whenever possible, use appendices to provide details, supplementary data, references, and information requiring in-depth analysis. These types of data, although supportive of the proposal, if included in the body of the design, could detract from its readability. Appendices provide the proposal reader with immediate access to details if and when clarification of an idea, sequence or conclusion is required. Timetables, work plans, schedules, activities, and methodologies, legal papers, personal vitae, letters of support, and endorsements are examples of appendices.

Contractors shall populate all attachments of this RFA that require the Contractor to provide information and include an authorized signature where requested. Contractor RFA responses shall include the following items and those attachments should be arranged in the following order: Number each page consecutively.

**A. Cover Page with all fields completed, signed by an authorized official of the Contractor organization**

**B. Face Page**

- 1) The Contractor's name and principal place of business.
- 2) The Contractor's legal status: i.e., whether the Contractor is an individual, a corporation, a general partnership, a limited partnership, a joint venture, or some other legal entity. The state in which the Contractor is incorporated or organized.

**C. Proposal Summary: (2 page limit) (10 points)**

The summary should be prepared after the application has been developed in order to encompass all the key points necessary to communicate the objectives of the project. It is the document that becomes the cornerstone of the proposal, and the initial impression it gives will be critical to success of the venture. In many cases, the summary will be the first part of the proposal package seen by agency and very possible could be the only part of the package that is carefully reviewed before the decision is made to consider the project any further.

**D. Organization Background and Qualifications: Describes the organization and its qualifications for funding (20 points)**

- 1) Mission and goal of the Organization
- 2) The details of:
  - i) Any criminal convictions of any of the Contractor or any of their officers, directors, employees, agents, or subcontractors of which the Contractor have knowledge or a statement that there are none;
  - ii) Any criminal investigations pending against of any of the Contractor or any of their officers, directors, employees, agents, or subcontractors of which the Contractors have knowledge or a statement that there are none;
  - iii) Any regulatory sanctions levied against any of the Contractors or any of their officers, directors, employees, agents, or subcontractors by any state or federal regulatory agencies within the past three years of which the Contractor s have knowledge or a statement that there are none. As used herein, the term "regulatory sanctions" includes the revocation or suspension of any license or certification, the levying of any monetary penalties or fines, and the issuance of any written warnings;
  - iv) Any regulatory investigations pending against of any of the Contractors or any of their officers, directors, employees, agents, or subcontractors by any state or federal regulatory agencies of which the Contractors have knowledge or a statement that there are none. Note: The Department may reject a proposal solely on the basis of this information.
  - v) Any of the Contractor's directors, partners, proprietors, officers, or employees or any of the proposed project staff are related to any DHHS employees. If such relationships exist, identify the related individuals, describe their relationships, and identify their respective employers and positions.
  - vi) Assurance that the Contractor and the proposed Contractor staff are not excluded from participation by Medicaid or the Office of the Inspector General of the United States Department of Health and Human Services.
- 3) Description of the following:
  - i. Current array of child/adolescent and adult services
  - ii. Primary population served
  - iii. How this pilot would support your efforts to improve child/adolescent and/or adult outcomes and safety
  - iv. Current mitigation and testing strategies and/or resources

**E. A written description of the Contractor’s approach to the project, including identification of key partners (20 points).**

### Relationships of the Parties

The Contractor represents that it has, or shall secure at its own expense, all personnel required in performing the services under this agreement. Such employees shall not be employees of, or have any individual contractual relationship with, the Division.

In case of default by the Contractor, without limiting any other remedies for breach available to it, the Division may procure the contract services from other sources and hold the Contractor

responsible for any excess cost occasioned thereby. The filing of a petition for bankruptcy by the Contractor shall be an act of default under this contract.

**Waiver of Default:** Waiver by the Division of any default or breach in compliance with the terms of this contract by the Contractor shall not be deemed a waiver of any subsequent default or breach and shall not be construed to be modification of the terms of this contract unless stated to be such in writing, signed by an authorized representative of the Department and the Contractor and attached to the contract.

**Availability of Funds:** The parties to this contract agree and understand that the payment of the sums specified in this contract is dependent and contingent upon and subject to the appropriation, allocation, and availability of funds for this purpose to the Division.

**Force Majeure:** Neither party shall be deemed to be in default of its obligations hereunder if and so long as it is prevented from performing such obligations by any act of war, hostile foreign action, nuclear explosion, riot, strikes, civil insurrection, earthquake, hurricane, tornado, or other catastrophic natural event or act of God.

**Survival of Promises:** All promises, requirements, terms, conditions, provisions, representations, guarantees, and warranties contained herein shall survive the contract expiration or termination date unless specifically provided otherwise herein, or unless superseded by applicable Federal or State statutes of limitation.

**Patents And Inventions:** Any invention or discovery made or conceived in the performance of this contract (hereinafter called "*INVENTION*"), and any patent granted on such *INVENTION* shall be jointly or individually owned by Contractor and/or Division in accordance with the following criteria:

- (a) Title to any *INVENTION* made or conceived jointly by employees of both Contractor and Division in the performance of this contract (hereinafter called "*JOINT INVENTION*") vests jointly in Division and Contractor.
- (b) Title to any *INVENTION* made or conceived solely by employees or students of either Contractor or Division in the performance of this Contract vests in the party whose employees or students made or conceived the *INVENTION* or discovery.

**Publication:** Contractor and its investigators are free to publish papers dealing with the results of the research project, if any, sponsored under this Contract. However, Division must be given thirty (30 days) to review such papers prior to any publication thereof. The Contractor shall acknowledge the Division's funding role in all publications.

**Similar Research:** Nothing in this Contract may be construed to limit the freedom of the Contractor or of its researchers who are participants under the Contract from engaging in similar research made under grants, contracts, or agreements with parties other than the Division.

**Federal Intellectual Property Bankruptcy Protection Act:** The Parties agree that the Division shall be entitled to all rights and benefits of the Federal Intellectual Property Bankruptcy Protection Act, Public Law 100-506, codified at 11 U.S.C. 365(n), and any amendments thereto.

### Compliance with Applicable Laws

**Compliance with Laws:** In the performance of this Agreement, the Contractor shall comply with all laws, ordinances, codes, rules, regulations, and licensing requirements that are applicable to the conduct of its business, including those of federal, state, and local agencies having jurisdiction and/or authority.

**Equal Employment Opportunity:** The Contractor shall comply with all federal and State laws relating to equal employment opportunity. In the performance of this Agreement.

**Health Insurance Portability and Accountability Act (HIPAA):** The Contractor agrees that, if the Division determines that some or all of the activities within the scope of this contract are subject to the Health Insurance Portability and Accountability Act of 1996, P.L. 104-91, as amended ("HIPAA"), or its implementing regulations, it will comply with the HIPAA requirements in the performance of this Agreement and will execute such agreements and practices as the Division may require to ensure compliance.

### Confidentiality

**Confidentiality:** Any medical records, personnel information or other items exempt from the NC Public Records Act or otherwise protected by law from disclosure given to the Contractor under this contract shall be kept confidential and not divulged or made available to any individual or organization without the prior written approval of the Division. Subject to the foregoing provisions, Contractor reserves the right to use the results of all services provided under this contract for its teaching, research, and publication purposes, provided such use is otherwise permitted by applicable law.

**Data Security:** The Contractor shall adopt and apply data security standards and procedures that comply with all applicable federal, state, and local laws, regulations, and rules.

**Duty to Report:** The Contractor shall report a suspected or confirmed security breach to the Division's Contract

Administrator within twenty-four (24) hours after the breach is first discovered, provided that the Contractor shall report a breach involving Social Security Administration data or Internal Revenue Service data within one (1) hour after the breach is first discovered. During the performance of this contract, the contractor is to notify the Division contract administrator of any contact by the federal Office for Civil Rights (OCR) received by the contractor.

**Cost Borne by Contractor:** If any applicable federal, state, or local law, regulation, or rule requires the Division or the Contractor to give affected persons written notice of a security breach arising out of the Contractor's performance under this contract, the Contractor shall bear the cost of the notice.

### Oversight

**Access to Persons and Records:** The State Auditor shall have access to persons and records as a result of all contracts or grants entered into by State agencies or political subdivisions in accordance with General Statute 147-64.7. Additionally, as the State funding authority, the Department of Health and Human Services shall have access to persons and records as a result of all contracts or grants entered into by State agencies or political subdivisions.

**Record Retention:** In accordance with the State's basic records retention policy, records resulting from these Services shall not be destroyed, purged, or disposed of without the express written consent of the Division during the period specified in the Stat's records retention policy and in accordance with state and federal law. State basic records retention policy requires all grant records to be retained for a minimum of five years or until all audit exceptions have been resolved, whichever is longer. If the contract is subject to federal policy and regulations, record retention may be longer than five years. Records must be retained for a period of three years following submission of the final Federal Financial Status Report, if applicable, or three years following the submission of a revised final Federal Financial Status Report. Also, if any litigation, claim, negotiation, audit, disallowance action, or other action involving this Contract has been started before expiration of the five-year retention period described above, the records must be retained until completion of the action and resolution of all issues which arise from it, or until the end of the regular five-year period described above, whichever is later. The record retention period for Temporary Assistance for Needy Families (TANF) and MEDICAID and Medical Assistance grants and programs must be retained for a minimum of ten years.

**Government Review:** To the extent required by applicable law and pursuant to written requests from any appropriate governmental authority, Contractor and the Division shall make available to such appropriate

governmental authority this Agreement and any books, records, documents and other records that are necessary to certify the nature and extent of the services provided and the cost claimed for services rendered pursuant to this Agreement or so as to otherwise comply with the requirements of any lawful agreement between the party and such governmental authority.

### Miscellaneous

**Choice of Law:** The validity of this contract and any of its terms or provisions, as well as the rights and duties of the parties to this contract, are governed by the laws of North Carolina. The Contractor, by signing this contract, agrees and submits, solely for matters concerning this Contract, to the exclusive jurisdiction of the courts of North Carolina and agrees, solely for such purpose, that the exclusive venue for any legal proceedings shall be Wake County, North Carolina. The place of this contract and all transactions and agreements relating to it, and their situs and forum, shall be Wake County, North Carolina, where all matters, whether sounding in contract or tort, relating to the validity, construction, interpretation, and enforcement shall be determined.

**Amendment:** This contract may not be amended orally or by performance. Any amendment must be made in written form and executed by duly authorized representatives of the Division and the Contractor. The Purchase and Contract Divisions of the NC Department of Administration and the NC Department of Health and Human Services shall give prior approval to any amendment to a contract awarded through those offices.

**Severability:** In the event that a court of competent jurisdiction holds that a provision or requirement of this contract violates any applicable law, each such provision or requirement shall continue to be enforced to the extent it is not in violation of law or is not otherwise unenforceable and all other provisions and requirements of this contract shall remain in full force and effect.

**Headings:** The Section and Paragraph headings in these General Terms and Conditions are not material parts of the agreement and should not be used to construe the meaning thereof.

**Gender and Number:** Masculine pronouns shall be read to include feminine pronouns and the singular of any word or phrase shall be read to include the plural and vice versa.

**Time of the Essence:** Time is of the essence in the performance of this contract.

**Key Personnel:** The Contractor shall not replace any of the key personnel assigned to the performance of this contract without the prior written approval of the Division.

The term "key personnel" includes any and all persons identified by as such in the contract documents and any other persons subsequently identified as key personnel by the written agreement of the parties.

**Care of Property:** The Contractor agrees that it shall be responsible for the proper custody and care of any property furnished to it for use in connection with the performance of this contract and will reimburse the Division for loss of, or damage to, such property. At the termination of this contract, the Contractor shall contact the Division for instructions as to the disposition of such property and shall comply with these instructions.

**Travel Expenses:** Reimbursement to the Contractor for travel mileage, meals, lodging and other travel expenses incurred in the performance of this contract shall not exceed the rates published in the applicable State rules. International travel shall not be reimbursed under this contract.

**Sales/Use Tax Refunds:** If eligible, the Contractor and all subcontractors shall: (a) ask the North Carolina Department of Revenue for a refund of all sales and use taxes paid by them in the performance of this contract, pursuant to G.S. 105-164.14; and (b) exclude all refundable sales and use taxes from all reportable expenditures before the expenses are entered in their reimbursement reports.

**Advertising:** The Contractor shall not use the award of this contract as a part of any news release or commercial advertising.

## Conflict of Interest Policy Example

The Board of Directors/Trustees or other governing persons, officers, employees or agents are to avoid any conflict of interest, even the appearance of a conflict of interest. The Organization's Board of Directors/Trustees or other governing body, officers, staff and agents are obligated to always act in the best interest of the organization. This obligation requires that any Board member or other governing person, officer, employee or agent, in the performance of Organization duties, seek only the furtherance of the Organization mission. At all times, Board members or other governing persons, officers, employees or agents, are prohibited from using their job title, the Organization's name or property, for private profit or benefit.

A. The Board members or other governing persons, officers, employees, or agents of the Organization should neither solicit nor accept gratuities, favors, or anything of monetary value from current or potential contractors/vendors, persons receiving benefits from the Organization or persons who may benefit from the actions of any Board member or other governing person, officer, employee or agent. This is not intended to preclude bona-fide Organization fund raising-activities.

B. A Board or other governing body member may, with the approval of Board or other governing body, receive honoraria for lectures and other such activities while not acting in any official capacity for the Organization. Officers may, with the approval of the Board or other governing body, receive honoraria for lectures and other such activities while on personal days, compensatory time, annual leave, or leave without pay. E. **Board Action** -- When a conflict of interest is relevant to a matter requiring action by the Board of Directors/Trustees or other governing body, the Board member or other governing person, officer, employee, or agent (person(s)) must disclose the existence of the conflict of interest and be given the opportunity to disclose all material facts to the Board and members of committees with governing board delegated powers considering the possible conflict of interest. After disclosure of all material facts, and after any discussion with the person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.

In addition, the person(s) shall not participate in the final deliberation or decision regarding the matter under consideration and shall leave the meeting during the discussion of and vote of the Board of Directors/Trustees or other governing body.

The law does not apply to children's services provided in private residences, facilities funded solely by Medicare or Medicaid funds, and portions of facilities used for inpatient drug or alcohol treatment. Failure to comply with the provisions of the law may result in the imposition of a civil monetary penalty of up to \$1,000.00 per day and/or the imposition of an administrative compliance order on the responsible entity.

The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter any lower tier covered transaction with a person who is debarred, suspended, determined ineligible or voluntarily excluded from participation in this covered transaction unless authorized by the department or agency with which this transaction originated.
6. The prospective lower tier participant further agrees by submitting this document that it will include the clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion--Lower Tier Covered Transaction," without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions.
7. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that it is not debarred, suspended, ineligible, or voluntarily excluded from covered transaction, unless it knows that the certification is erroneous.
