Equifax Government Solutions began moving customers to their enhanced web platform, October of 2024, the **Verification Insights Portal™** (VIP). They will complete the VIP upgrade for all customers by January 31, 2025. The existing web portal platform will sunset on January 31, 2025. This will affect those who use the web-based version of The Work Number.

VIP will provide an enhanced user experience with interactive, additional functionality that has been requested by customers over the years. VIP will be visually appealing and offer user-friendly access to any solution you are contracted for under a single location and credential.

What to expect

- On the date of the upgrade, users will be automatically redirected to the new VIP.
- No change is required for how users log in or the credentials that are used.
- Information obtained through VIP will be the same as the information currently being provided.
