## SUBJECT: INTAKE & ASSESSMENT USER ACCEPTANCE TESTING-READOUT AND NEXT STEPS

## **REQUIRED ACTION:** Information Only Time Sensitive Immediate

This DCDL is in follow up to the previous DCDL from February 14, 2025 "Intake & Assessment User Acceptance Testing – Readout & Next Steps."

We have been working diligently to implement the feedback from Phase 1 of Intake & Assessment (I&A) User Acceptance Testing (UAT). Our DHHS team received positive feedback from county staff on the proposed design adjustments and have been working with Deloitte to implement the changes in PATH NC. We are pleased with the progress and the speed at which changes are able to be made in this new platform.

After thoroughly analyzing the impacts of the additional time that was needed for these changes, we have been able to establish new dates for UAT Phase II, End User Trainings, and Rollout Dates:

- UAT Phase II: April 2, 2025 April 4, 2025
  Group 1 End User Training: May 12, 2025 May 30, 2025
- Group 1 Go-Live: June 2<sup>nd</sup>, 2025

The full proposed rollout schedule with Groups 1-6 is attached to this letter. Ongoing Case Management rollout dates have not yet been finalized but are planned to begin in early calendar year 2026.

We apologize for any inconvenience this schedule change may have caused. However, our commitment to providing a user-friendly system that aligns with our guiding principles is of the utmost importance and we believe that the extra time was needed to honor that commitment.
