North Carolina Division of Social Services (NCDSS) would like to thank you for your support with the NYTD 2024A Follow-Up surveys. We are now preparing for the National Youth in Transition (NYTD 2024B) Follow-Up reporting period that began on April 1, 2024, and ends September 30, 2024.

Each county agency has been provided a NYTD eligible youth list by email. While all eligible youth must complete the survey before the September 30, 2024, cohort deadline, it is recommended that eligible youth complete the survey as soon as possible. The NYTD 2024B stipend incentive for the follow-up population of youth 21 years of age has been increased and is now \$200.00 for each participating youth.
