SUBJECT: REGULATORY AND LICENSING UPDATES

North Carolina Division of Social Services (NCDSS) recognizes that many licensed foster families, residential group homes, child placing agencies, and adoption agencies have been greatly affected by the devastating damage and loss as a result of Hurricane Helene. These families and agencies have continued to ensure the safety and well-being of children in their care even as their families were being displaced and their homes were damaged or destroyed.

The attachments to this letter will address how the NC Regulatory and Licensing office will assist displaced foster families during this State of Emergency and which administrative rule flexibilities are allowable by Executive Order 319. This is applicable for all licensed foster families, child placing agencies, adoption agencies, and residential group homes in North Carolina counties named in the September 28, 2024, Federal Major Disaster Declaration: Alexander, Alleghany, Ashe, Avery, Buncombe, Burke, Caldwell, Catawba, Clay, Cleveland, Gaston, Haywood, Henderson, Jackson, Lincoln, Macon, Madison, McDowell, Mecklenburg, Mitchell, Polk, Rutherford, Swain, Transylvania, Watauga, Wilkes, Yancey, and the Eastern Band of Cherokee Indians.

The (3) three attachments include:

- The *Displaced Foster Family Guidance* provides guidance on how NCDSS will address displaced foster families as they recover from Hurricane Helene.
- The *Licensing Waivers-Executive Order 319* document provides a detailed description of the administrative rules that will be waived during the state of emergency.
- The At a Glance: Regulatory and Licensing Flexibilities for Hurricane Helene document provides a one-page, condensed version of the administrative rule flexibility for staff to easily locate and understand the flexibilities being provided during this time.
