DAAS utilizes three main platforms for communications as follows:

1. **NC DAAS LMS**: The NC DAAS LMS platform is found at <https://ncdaas.myabsorb.com/#/login>. This learning management system hosts the schedules and registrations for all DAAS trainings as well as DAAS micro-learning and on-demand training content.
2. **Special Assistance and Adult Services SharePoint Site**: The SharePoint site is a website that provides forms, manuals, updates, etc. in one location. The SharePoint site can be accessed at [Special Assistance - Adult Services - Home \(sharepoint.com\)](#).
3. **Adult Services Supervisors Listserv**: DAAS team members utilize the Adult Services e-mail listserv to share important updates with all 100 counties in real time. - Requesting technical assistance with a non-emergent technical issue on the NC DAAS LMS, the SharePoint site, and the Adult Services Supervisor's listserv.

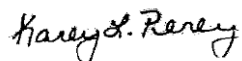
