Complete, sign, and return the funding format for the Adult Home Specialist Fund, Adult Protective Services SSBG, State In-Home Fund and State Adult Day Care Fund (where applicable) to the attention of Kent Woodson as directed on the funding authorization format.

Note that the funding authorization has changed in appearance from last year's format. This has been done to allow for clear tracking of any realignments that occur throughout the year. In the coming year DAAS will be soliciting feedback from local DSS offices in establishing a funding methodology that will seek to be both fair and reflect both current needs and historical utilization. Realignments in the Adult Day Care Fund in SFY 17-18 were all completed on a non-recurring basis, current allocations reflect the same allocations as those at the start of last fiscal year.
