FY 2020-2021 AAA SELF-ASSESSMENT

The Division of Aging and Adult Services (DAAS) annual “*Self-Assessment Guide for Monitoring the Area Agencies on Aging*” (AAA) is the basic monitoring tool used to determine risk assessments for programs administered by and subcontracted through the AAA requiring your review and completion. Once completed, the self-assessment is used to help DAAS determine, by program, areas where monitoring may be needed or required. Due to COVID-19, monitoring is being conducted under alternative methods such as desk reviews or virtual conferences as referenced in DAAS Administrative Letter 20-21.

Monitoring will be scheduled with each AAA Administrator in late January 2021. The purpose of monitoring is to assure that Area Agencies on Aging are in compliance with the requirements of the Older Americans Act (OAA). Monitoring will begin in February 2021 and continue through May 2021.
