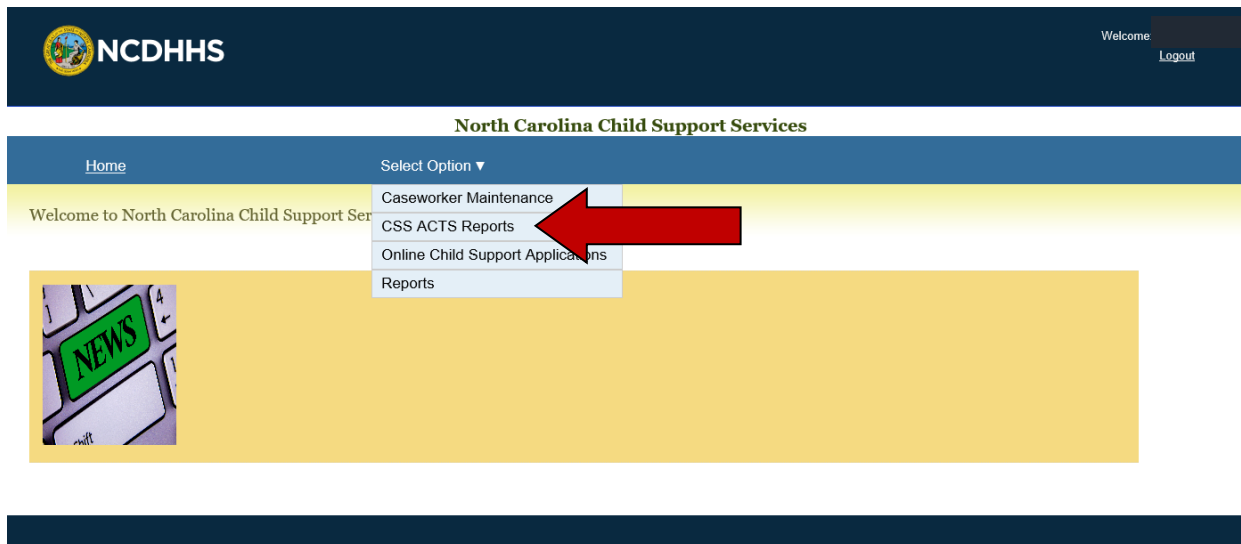


## CSS ACTS Reports on Worker Portal

As of 1/31/2021, XNET will be decommissioned. The reports previously accessed via XNET will be made available on the Worker Portal. Users will still have access to XPTR via the mainframe. Instructions for accessing the reports via the Worker Portal are below.

### Accessing the Reports

1. Logon to the CSS Worker Portal at <https://css.dhhs.state.nc.us/ecwa/>.
2. Click on “NC Child Support Portal” then use your NCID login information to access the portal.
3. After entering your NCID information to login, Multi-Factor Authentication (MFA) will be required in order to proceed. You will receive a phone call prompting you to enter your MFA PIN#. This will be the same four-digit PIN# used for ACTS MFA. If you are not currently registered for MFA, please contact the Security Team at [css.security@dhhs.nc.gov](mailto:css.security@dhhs.nc.gov).
4. After logging in, you will use the drop-down menu, “Select Option” and click on “CSS ACTS Reports”



5. From the CSS ACTS Reports page, the options are “All Reports” or “My Favorites”
