SUBJECT: MEUC UIB Type

REQUIRED ACTION: Information Only Time Sensitive Immediate

The Online Verification (OLV) system now displays another type of Unemployment Insurance Benefit, Mixed Earner Unemployment Compensation (MEUC) Benefits. This additional weekly benefit is available from 12/27/2020-09/04/2021 to individuals with at least \$5,000 in net income from self-employment during the applicable tax year.

The chart below provides an example of how MEUC information will appear in OLV.
