SUBJECT: FAMILY SUPPORT/FAMILY RESOURCE CENTER SERVICES REQUEST FOR APPLICATION (RFA)

The North Carolina Department of Health and Human Services' Division of Social Services is pleased to announce the availability of Family Support and Family Resource Center Services funds for State Fiscal Year (SFY) 2010-2011. The US Department of Health and Human Services, Administration for Children and Families authorizes funding for grants under this announcement. Applicants should note that the grant award is subject to the availability of funds.

Please note that for SFY 2010-2011, the Division of Social Services has integrated its Special Initiatives program areas of Fatherhood, Healthy Marriages, and Faith Based services into the Family Support and Family Resource Center Services RFA. Grantees currently providing Special Initiatives services under contract with the Division of Social Services who have an interest in continuing services are encouraged to submit an application in response to the Family Support and Family Resource Center Services RFA announcement.

The RFA document describes the program service requirements, eligible applicants and the application requirements. Applicants must use the required documents and format stipulated in the RFA Guidelines. This is a competitive process and each application will be reviewed separately. Applications will be evaluated according to completeness, content, experience with similar projects, and ability and capacity of the organization to implement the project.

Please note all agencies considering applying for these funds must submit a Letter of Intent. Agencies that do not submit a Letter of Intent will not be considered for funding and their application will be disqualified if submitted. The Letter of Intent should be submitted via e-mail to Kristin O'Connor at Kristin.oconnor@ncmail.net by Monday, February 16, 2009, no later than 5:00pm. Technical Assistance conference calls will be held on Friday, February 20, 2009. All agencies that submit a letter of intent will be invited to participate in the technical assistance sessions.

Applications are due in the Community Based Programs Office, Room 787, on or before Friday, March 6, by 5:00 p.m. Notification of funding decisions will be provided to all applicants in writing by May 1, 2009.
