

Blended Roles in NC FAST

Overview

The purpose of this job aid is to identify the high-level capabilities available to users for new blended security roles in NC FAST. This document will be updated with additional blended security roles as they are made available to users.

Blended security roles provide Child Welfare staff with the ability to access the Child Welfare and Economic Benefit functions in NC FAST using a single username and password. Previously this required multiple roles. There are requirements that need to be met before these roles can be accessed. For more information refer to the notes below.

| Child Welfare Social Worker Supervisor EBI | Access Child Welfare Social Worker Supervisor functions plus inquiry-only access to Economic Benefits programs. |

| DSS Director | Access DSS Director functions plus inquiry-only access to Economic Benefits programs. |

Notes:

- **DSS Directors** – To use the new DSS Eligibility Director blended security role, the person must have completed the required eligibility training. To acquire a DSS Eligibility Director security role, a user must submit a request from the county’s NC FAST System Administrator. For more information, see the Appendix below.
- **Child Welfare Program Managers** – To use the Child Welfare Program Eligibility Manager blended security role, the user must have the requirements in their job description to supervise or manage both the Child Welfare and the Economic Benefits programs, and must complete required eligibility training. To acquire a Child Welfare Program Eligibility Manager security role, a user must submit a request from the county’s NC FAST System Administrator.
