SUBJECT: SFY 2007-2008 FACILITY RATES

EFFECTIVE: SEPTEMBER 1, 2007

The purpose of this letter is to provide you with information on the **Foster Care Maximization Program** and the list of **Facility Rates** for participating agencies for SFY 2007-2008. The DHHS Controller's Office is responsible for establishing **Facility Rates** (i.e. cost-of-care rates) for agencies that participate in this program. In order to participate, agencies must comply with program requirements in North Carolina Administrative Code (10A NCAC 70D). The regulations in 10A NCAC 70D reflect federal regulations with which the DHHS Controller's Office, the Division of Social Services and agencies must comply in order for North Carolina to maintain this program. Private child-caring agencies must enter into a formal contract with the Division in order to receive reimbursements directly from the state.

A standardized approach for establishing facility rates is underway which recognizes the application of licensing standards, a cost model rate plan and best practices. At this point in time, the process for establishing all rates has not been completed. The Division will continue to work diligently with providers over the next few months to complete the rate setting process. County Departments of Social Services should anticipate the standardized rates in July 2008.

The attached list contains the providers currently participating in the facility rate process along with their new rates, **effective September 1, 2007**. The rates are based on an inflationary cost adjustment to the prior fiscal year amounts. They are a replacement for the current facility rates, and will remain in place until finalization of the new facility rates. New

rates were anticipated to be in place by September 1, 2007 and that is not possible due to the need for further work.

Establishing **Facility Rates** allows North Carolina to claim additional federal IV-E and TEA foster care reimbursements for county DSS agencies and participating private childcaring agencies. Specifically, this program enables the state to receive federal IV-E and TEA reimbursement for foster care costs in excess of the standard board rate that are incurred on behalf of IV-E and certain TEA eligible children.

If the cost of a child's placement is in excess of the standard board rate, it is very important that county DSS staff ensure that the child-caring or placement agency is participating in the current maximization program. If a county DSS determines that a potential placement resource for an eligible child does not have a Facility Rate established by the DHHS Controller's Office, the county DSS who places the minor will be responsible for the portion of the cost of care in excess of the standard board rate. The facility or agency may contact Tina Bumgarner at (704) 462-2686 to determine if they meet the requirements and to request inclusion in the Maximization Program.

For child-caring facilities operated by county Departments of Social Services, federal IV-E and TEA maximization reimbursements are received directly by the county Department of Social Services. In such situations, the established monthly **Facility Rate** must be shown in Field 50 (Monthly Rate) of the DSS 5094 in order for the county DSS to receive the full maximization reimbursement.

According to federal and state regulations, foster care payment claims are not allowed to exceed the state-established Facility Rates. In addition, North Carolina Administrative Code includes a cost containment requirement in which the Child and Family Services Association of North Carolina recommends a cap or <u>maximum facility rate</u> for each type of care each year. Therefore, no **Facility Rate** established by the Division is allowed to exceed the maximum rate established, regardless of the facility's actual cost of care.

The monthly caps (allowable maximum facility rate) for each type of care related to the 2007-2008 Facility Rate period, effective <u>September 2007</u>, are as follows:

Family Foster Care: Administration = 1852, Maintenance = 2041 Group Care = 6403 Institutional = 6577 Emergency = 6471 Therapeutic Camping = 4179

The state averages for each type of care related to the 2007-2008 Facility Rate period, effective <u>September 2007</u>, are as follows:

Family Foster Care: Administration = 1095, Maintenance = 1095 Group Care = 5228 Institutional = 5128 Emergency = 5359 Therapeutic Camping = 3884 Agencies qualifying for IV-E maximization in one type of care, and begin offering an additional type of care during the SFY, will be authorized for the state average for that new type of care.

State Fund Agency members are indicated with an asterisk (*) on the enclosed list. These agencies have the potential for possible supplemental funds to assist with the foster care placement costs for <u>non-IV-E children</u>, with member agencies. Reimbursements are made based on the available funds, the agency's Facility Rate, the additional population served, and the foster care payment and resources reflected on a child's DSS 5094 form.
