Subject: Head Start Programs and Work First Collaboration

The North Carolina Division of Social Services and the Head Start State Collaborative Office have developed a workgroup. The purpose of this group is to strengthen partnership between the agencies to assist families of North Carolina in receiving available services and benefits.

Departments of Social Services (DSS) and Head Start agencies throughout the state offer a variety of programs including child care and other services to support families. Local county Department of Social Services Work First programs are encouraged to continue working collaboratively with local Head Start agencies to establish protocols to ensure that participants are aware of both programs and their benefits. The collaboration of services will strengthen relationships between agencies and improve outcomes for Work First and Head Start families.

Currently, the Head Start State Collaborative Office is providing grant opportunities to local Head Start agencies interested in working more closely with their local DSS agencies. The goals of the grants include:

- increasing the enrollment of Work First families participating in Head Start programs
- increasing referrals
- developing effective communication
- providing joint training opportunities

The Head Start State Collaborative Office is hosting webinars to discuss collaboration with local DSS agencies. The Division encourages local DSS agencies to participate in these webinars as your schedule permits, in order to facilitate on-going partnerships at the local level. The webinars are currently scheduled for Tuesday, July 9, 2013 at 11:15 am and Thursday, July 11, 2013 11:15 am.
