Re: County Assignments for Division of Social Services Hearing Officers

Over the last two years, the Office of Hearings and Appeals has experienced an increase of approximately 35% in the number of appeals filed by County Departments of Social Services on behalf of clients. In order to help handle this increase in appeals, we have had to add two additional Hearing Officers to our staff. Ms. Stephanie McNeill and Ms. Angela Aldridge joined our staff within the last few weeks. Prior to joining Hearings and Appeals, Ms. McNeill worked with Disability Determination Services within the Department of Health and Human Services. Ms. Aldridge worked with Pamlico Sound Legal Services in Greenville.

Since we have two additional staff, we have realigned the counties served by Hearing Officers. Effective June 17, 2002, the areas for Hearing Officers are reflected on the attachment to this letter. The new county assignments are for new appeals cases received in our office on or after June 17, 2002. The Hearing Officers originally assigned to cases that have a decision date that is due between now and July 15, 2002 are still handling those cases.
