Subject: LME-MCO Audit and Edit Resolution Page Access

The purpose of this bulletin is to provide instruction in how the LME-MCOs can access the DMA Audit and Edit Resolution pages.

During the past few months the Claims Adjudication Workgroup has been working with a select group of LME-MCO representatives in order to clarify issues around the LME-MCOs getting access to the DMA Audit and Edit Resolution pages. Information Technology staff at your agencies have outlined compelling reasons as to why access to the information is needed.

Based on the justification outlined by the LME-MCOs, and with guidance from correspondence generated by the Centers for Medicare and Medicaid Services, we have created an **Audit/Edit Resolution packet** for your use.

The **Audit/Edit Resolution packet** includes the following information:

- **Encounter Edits and Audit Disposition**--Complete edit list with code, description, and disposition (Deny, Pay and Report, Ignore)
- **NC MMIS Edit Resolution Manual—Your agency will receive access to the Edit and Audit resolution tables via the NCTracks portal.** Instructions on how to access the tables via NCTracks are included.

- **Audit/Edit Resolution table access list**--Please return the attached *Audit/Edit Resolution table staff access list* by January 29, 2016 to [Adolph.Simmons@dhhs.nc.gov](mailto:Adolph.Simmons@dhhs.nc.gov).
