Director's Message




Kathy Smith Director, DVRS I'm so pleased to say that this has been another busy year, with important successes to celebrate. We continued to provide vital services to people with disabilities in all 100 counties, expanded our partnerships across the disability services system, and launched new programs, like Project Spark!, to increase opportunities for people with more complex barriers to employment and independent living.


Over the last year, more than 23,906 clients received employment services under an individualized plan, with 2,927 achieving their goal. Another 6,000 students with disabilities received pre-employment transition services to explore career options and prepare for life after high school. We provided independent living services to an additional 2,044 consumers, with 794 reaching their goals. We also saw inital success in efforts to reduce vacancy rates across the division, and specifically for rehabilitation counselors. As we implement new


recruitment and retention incentives in the coming year and increase awareness of career opportunities with our agency, we hope for even more success in this area.




Clients Receiving Services Under Individualized Plan for Employment (IPE)

Youth and Student Services



6,019 students participated in Pre-ETS to help them explore career options and prepare for the transition from high school to adult life



ansition Services

1,303 transition-aged youth received services to help explore and pursue career goals as they enter into post-secondary education, training, and other workforce preparation activities

1,261 transition-aged youth successfully exited the VR program after achieving their unique goals for competitive integrated employment and more independent living

SPARKING OPPORTUNITIES

The North Carolina Division of Vocational Rehabilitation Services received a \$13.8 federal grant to increase employment opportunities for people with intellectual and developmental disabilities. Over a 5-year period, the Subminimum Wage to Competitive Integrated Employment grant, renamed Project Spark, will support 300 individuals currently engaged in or thinking about entering subminimum wage employment as they transition to CIE.

People engaged in CIE work alongside other employees without disabilities. They earn at least minimum wage and get the same workplace benefits and opportunities as other employees doing the same job. Working in CIE helps people with intellectual and developmental disabilities engage more fully in the community. They develop meaningful relationships with peers and build new skills and self-esteem. This offers a pathway that leads to more informed choices and greater independence. In partnership with three community rehabilitation programs, Project Spark is conducting outreach activities to recruit more participants, employers and service providers, and will soon be launching on social media - so stay tuned!

Independent Living Services



794 clients achieved their independent living goals



2,044 clients received services as part of their Independent Living Plan



856 Individualized **Plans for Independent Living** were developed and signed during the program year.



Of **1,781** applicants, **84%** were eligible for IL Services. Ineligible applicants were referred to other resources.

Assistive Technology Services



12,303 clients received services from the NC Assistive Technology Program



1,111 individuals received training to help them use AT software and devices



80 individuals received new or refurbished AT devices and equipment at no cost




81,799 dollars saved by North Carolinians with disabilities on the purchase of AT




