SY 20-21/SY 21-22 STUDENT P-EBT COMPARISON**

The United States Department of Agriculture (USDA) is the federal agency that authorizes Pandemic EBT (P-EBT) and creates program rules. USDA released new guidance for P-EBT in SY 21-22. To comply with USDA guidance and with most children back to in-person school and receiving their meals at school, the North Carolina P-EBT program has adjusted the eligibility criteria and calculation of benefits for Student P-EBT this school year. Outlined below are the high-level changes to P-EBT for students in SY 21-22.

HOW TO USE THIS CHART

This chart shows a comparison for Student P-EBT last school year (SY 20-21) and Student P-EBT for this school year (SY 21-22). Use the chart below to see what has **stayed the same** and what has **changed**.

***KEY DEFINITIONS**

Quarantine (use attendance code 1D for quarantine)

A student may be considered in quarantine when the school tells the student to **stay home because of COVID-19 related symptoms, illness, or exposure**.

A student may also be considered in quarantine if the parent or guardian informs the school about a student's COVID-19 related symptoms, illness, or exposure and the school approves the absence.

Temporary virtual instruction (use attendance code 1R for present off-site)

A student is considered in temporary virtual instruction when the student is enrolled in a physical school but is **in virtual or remote learning for a temporary period of time because of a COVID-19 incident or reason**. Students can be in temporary virtual instruction if they are enrolled in a physical school. ***Students in virtual academies are not in temporary virtual instruction.***
