**SUBJECT:** Update to Transitions to Community Living (TCL) Employment Incentive Plan

This bulletin amends [Joint Communication Bulletin #J435](#), distributed on Oct. 12, 2022, regarding the Transitions to Community Living (TCL) Employment Incentive Plan and revises the timeline for submission of quarterly performance measure data to account for lag time in service claims processing.

LME/MCOs (future Tailored Plans) will submit quarterly employment performance measures to DMH/DD/SAS at [IPS.incentive@dhhs.nc.gov](mailto:IPS.incentive@dhhs.nc.gov) by the **seventh** business day of the fourth month following each state fiscal year quarter. For any quarter that a measure value does not meet or exceed the performance target, LME/MCOs may resubmit data and supporting documentation by the **seventh** business day of the seventh month following the state fiscal year quarter. Submission due dates for the next four measurement periods are:
