



Donyel B. Barber, a Gaston County native, is a dedicated community leader and advocate for health equity. She has served in various roles, including serving as a Child Protective Services worker for nearly 9 years, serving as an Executive Director of Family Promise of Gaston County, and currently working as Director of Health Equity Initiatives at Kintegra Health.

Donyel has contributed to the betterment of the community and beyond through various civic and social affiliations. She currently serves as a board member for the following organizations: Diversified Business Professional Foundation, Ashbrook Foundation, The Carrie E. and Lena V. Glenn Foundation and Communities Joined In Action. Donyel is a member of the Delta Sigma Theta Sorority, Inc. She is Past President of the sorority's Gastonia Alumnae Chapter and currently serves as Parliamentarian and member of the Policies and Procedures and Social Action committees. She is a charter member of the Gastonia Piedmont Chapter of Jack and Jill of America, Inc. and member of the Piedmont NC Chapter of The Links, Inc.

Recognized for her impactful work, Donyel has received numerous awards, including a Lifetime Achievement Award from President Barack Obama. She also made history as the first African American female elected to the Gastonia City Council.

Carolina Siliceo Perez has served as the Acting Director for the Latinx and Hispanic Policy and Strategy Program within OHE since June 2024. As an immigrant born in Mexico, raised in Western North Carolina, former DACA recipient, language justice worker and daughter of farm workers, Carolina brings a unique perspective and passion for helping others and advocating for equity in her community. Prior to taking the role as acting Director, Carolina worked with NCDHHS divisions and partners as OHE's Latinx Policy and Strategy Project Manager.

Carolina has an extensive public service background that extends beyond her time with NCDHHS. She was instrumental in supporting Buncombe County's COVID-19 response efforts facilitating many townhall conversations in Spanish and helping strengthen partnerships between government and the Latinx community. She previously held positions in the Vital Records Department and the Buncombe County Sheriff's Office, where she led the development of the U/T Visa Policy for undocumented crime victims. Carolina's efforts have led to the creation of Language Access Policies and Plans, supported by Building Integrated Communities and UNC Chapel Hill's Institute for the Study of the Americas. Beyond her professional work, Carolina is known for her advocacy in educational equity, immigrant rights, language justice and health care access, as well as her creative writing and public speaking. She also serves on the board of Colaborativa la Milpa and the Western Carolina Medical Society.

## **Medicaid Health Equity Report**

NC Medicaid serves almost 3 million low-income individuals and families, placing it in a unique position to track health disparities and improve the health of populations that have been systemically discriminated against. To help identify and address these disparities, NCDHHS Division of Health Benefits (DHB) developed the 2022 Annual Health Disparities Report, which outlines health disparities across the entire NC Medicaid beneficiary population.



When relevant and available, data about disparities is accompanied by historical and national context and information about programs and policies that NC Medicaid has that could address the identified disparity.

## NCDHHS Language Access Plan (LAP): Background

#### **FALL 2023**

Office of the Governor requests participation from all cabinet agencies in the creation and/or revisions of agency-level Language Access Plans and Policies.

#### **FEB 2024**

NCDHHS Divisions (14) surveyed to assess current state of language access at NCDHHS.

#### **MAY 2024**

Partners share survey results, data analysis regarding language access needs and template for Language Access Plan (LAP).

#### **MAY 2024**

Project leadership transitions.

#### **JUNE-SEPT 2024**

OHE and E&I representatives draft initial portions of LAP, identify key resource and support needs. Designation of Project Management Support.

#### **OCT-DEC 2024**

OHE drafts LAP and obtains reviews of LAP through December 2024 when draft is finalized.

NCDHHS has 33 divisions and offices, many programs and teams interact directly with the community and with community-based organizations. The interaction varies from team to team. Engagement includes: Presentations, Facebook live events, Outreach by attending health and resource fairs, Speaking at community events, summits, conferences, etc., Webinars, Newsletters, Press Releases- Secretarial Directives, Policies, Website, Direct services

- Division of Public Health examples: vital records birth and death certificates; contact tracing and case investigation; communication (often through Local health departments) about health promotion opportunities (get screened for cancer, get vaccinated) as well as risks (exposure to PFAS, lead, etc)
- Divisions of Services for the Blind, Services for the Deaf and Hard of Hearing, Employment
  and Independence for People with Disabilities (formerly known as Vocational Rehabilitation
  Services) all provide direct services via networks of local offices, including equipment loans
  and purchases, counseling, assessments, training, etc. Additionally, these divisions
  purchase services from vendors, like surgeries and treatments, job development and
  coaching, etc.
- Division of Social Services provides cash assistance or in-kind benefits program services to individuals and families promoting, self-reliance and self-sufficiency through County
   Departments of Social Services, Community Providers, and directly through Customer Call Centers. Direct services to beneficiaries, recipients of care via contracted agencies and providers

## NCDHHS Policy on Meaningful Access for Individuals with Limited English Proficiency and Equal Opportunity Participation for Individuals with Disabilities

#### STATE OF NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES

Policy on Meaningful Access for Individuals with Limited English Proficiency and Equal Opportunity Participation for Individuals with Disabilities

#### I. POLICY

The North Carolina Department of Health and Human Services (the Department) is prohibited from discriminating on the basis of national origin and disability in violation of *Title VI of the Civil Rights Act of 1964*, *Section 504 of the Rehabilitation Act of 1973*, *Title II* and *Title III of the Americans with Disabilities Act of 1990 (ADA)*, as amended by *ADA Amendments Act of 2008*, and other applicable federal and state laws and their implementing regulations with respect to access for individuals with Limited English Proficiency (LEP) and for individuals with disabilities. Additionally, the Department is prohibited from retaliating against anyone for engaging in a protected Civil Rights activity. All programs or activities administered by the Department or by an entity on behalf of the Department must take adequate steps to ensure that their policies and procedures do not deny or have the effect of denying individuals equal and meaningful access to programs, activities, benefits, and services for which such persons qualify.

#### II. PURPOSE

This policy ensures the Department and its divisions, offices, and facilities, including local entities, agents, providers, instrumentalities, public entities, and public accommodations take reasonable steps to ensure meaningful access for individuals with limited English proficiency (LEP) and provide equally effective communication for individuals with disabilities when accessing the Department's programs and activities.

#### **Link to NCDHHS Policy**

#### **NCDHHS** Language Access Outreach Highlights

- Translated information about Medicaid Expansion into 18 languages and hosted outreach events to promote expansion statewide.
- Facilitated services for over 10,000 new arrivals to our state, helping 1600 individuals secure employment and more than 1000 individuals access to targeted healthcare support.
- Supported interpretation for NCDHHS and partner events focused on behavioral health, mental health, seasonal vaccines, respiratory health, assistive technology for community inclusion, health disparities report, youth vaping prevention, suicide prevention, crisis services, low-income energy assistance program, medical debt relief and more.

### **NCDHHS** Language Access Plan – Updates

- NCDHHS is working with Neimand Collaborative to support the development and implementation of a department-level language access plan.
- Aligning draft plan with existing policies and other relevant plans.
- Collecting data, mapping resources, establishing and/or standardizing operating and reporting procedures.
- Developing an implementation toolkit to support program- and division-level language access plans.



## Minority Diabetes Prevention Program: Medicaid Codes

OHE applied for coverage for the National Diabetes Prevention Program (DPP) through North Carolina Medicaid on October 23, 2024. This request will have potential cost savings to the Medicaid program as well as reductions to providers' workload and an increase in beneficiaries' quality of care.


#### **Cost Comparison**

- Program Cost: The cost to cover their participation in a diabetes prevention program would be around \$345.6 million. Billing codes are the same as Medicare DPP
- Medical Expenditures: In contrast, medical expenditures related to diabetes totaling \$5.54 billion


## OHE What's Next: Building Sustainability and Enabling Impact for OHE's Core Functions

- CDC Grant NC Counts Coalition Contract: Coordinate and oversee contract and renewed partnership to support Hurricane Helene relief efforts.
- New Staff Hiring / Onboarding: Hire and onboard new community and partner engagement and data and evaluation staff.
- ➤ Health Equity Accreditation: Partner with URAC, nonprofit health care accreditor, to co-create a health equity accreditation for state government entities. Establish an Advisory Group and apply for NCDHHS health equity accreditation.
- Medicaid MOA: Increase accessibility and quality of Medicaid programs by executing contracted activities in partnership with the Division of Health Benefits (Medicaid).
