


#### NC Office of Rural Health Quarterly Newsletter

#### WESTERN SAT NEWS AND HIGHLIGHTS:



Hurricane Helene

Affected counties include: Alexander, Alleghany, Ashe, Avery, Buncombe, Burke, Caldwell, Catawba, Clay, Cleveland, Gaston, Haywood, Henderson, Jackson, Lincoln, Macon, Madison, McDowell, Mitchell, Polk, Rutherford, Transylvania, Watauga, Wilkes, and Yancey.

In the aftermath of Hurricane Helene, healthcare organizations across Western North Carolina have faced significant disruptions. Flooded roads, power outages, internet loss, and water service disruptions have made access to care difficult for rural communities, leading to delays in critical services. Many healthcare facilities have experienced infrastructure damage, straining already limited resources.

Despite these challenges, local healthcare providers are working tirelessly to maintain services and support their communities. Efforts include mobilizing mobile clinics to reach isolated areas, coordinating with state agencies for additional supplies, and more. As the response shifts from crisis to recovery, the resilience of the region's healthcare system highlights the importance of emergency preparedness and ongoing support for rural health infrastructure.

SUGAR GROVE — A group of nurses worked to transport supplies and medical help to people in difficult-to-reach areas with an old-fashioned means of travel: horseback.

"We heard you guys got hit pretty hard obviously so we put together crews that can go out with some folks with backcountry experience to be able to access more remote areas and bring medical care out there if they need it," said Mollie Brooks, who helped organize the effort.



On Wednesday, Oct. 2, the group had approximately 25 horses and people staging to help out. They also had a farrier [an animal hoof specialist] onsite in case any of the horses got hurt. Brooks said they worked with the sheriff's office to help organize the efforts as everyone helping out there is not from the area. "The goal is just to offer you guys more resources," she said.

Angelica Brown is a nurse from Catawba County who was looking for ways to help with the recovery.

"We're all nurses, so really medical is what we can offer y'all, so that's what we're here for," Brown said. "I have ridden horseback and done a lot of nursing. I have never mixed the two together, so today will be a first."

The teams were staging in the Sugar Grove area as they worked with Cove Creek Volunteer Fire Department for assignments.

## HRSA Administrator Johnson Visits Wilson County, Announces \$9 Million in Funding for NC Communities



Wilson County Substance Prevention Coalition was awarded a nearly \$3 million federal grant aimed to expand recovery and treatment services here and in Nash, Edgecombe, Warren and Wayne counties. Carole Johnson, administrator of the Health Resources and Services Administration, made the announcement in Wilson on Monday, September 23. The Health Resources and Services Administration is an agency of the U.S. Department of Health and Human Services. The coalition will receive about \$750,000 each year for four years and will facilitate into other

rural counties. The goal is to replicate what has worked in Wilson surrounding recovery and treatment for substance use disorders.

Johnson also announced an additional \$6 million for two other North Carolina agencies — United Way of Rutherford County and Integrated Care of Greater Hickory.

Jeff Hill, Wilson County Substance Prevention Coalition director, said Wilson's success is driven by the collaborative efforts among various agencies. He said the coalition is excited about the substantial funding that will allow them to serve more people.

Susan Lowe, a volunteer at **Brunswick Senior Resources**, shares about her volunteer work with Marilou Smith. "What I enjoy most about volunteering with Marilou is seeing how much the clients appreciate her and the effort she puts into helping them afford and receive the medications they need. I really like talking to the clients as I fill out their applications and follow up on paperwork. It's surprising but nice when some clients recognize my voice—it makes me feel valued. I love knowing I'm making a difference in their lives. Many people I speak with aren't able to take their prescribed medications because they can't afford them, sometimes not even the co-pay. I've learned how to help by offering them suggestions for lowering costs through coupons and the BFA program. Listening to the clients and referring them to other BSRINC resources when needed has been rewarding as well.

I also volunteer at the Dental and Medical Clinic at St. Mary's Basilica in Wilmington, where they offer affordable services, and it's been another great resource for some of our clients. Marilou is always flexible with the days and times I can come in. She'll leave me tasks to work on or send me emails to follow up with clients.

I really value the trust she places in me, which lets me give back to others while enjoying my retirement. I plan to continue volunteering with BSRINC for a long time." The Office of Rural Health would like to thank both Susan Lowe and Marilou Smith for their volunteer efforts. # Funding and Research Opportunities ORH Funding Opportunities

Working title of the funding program: Community Health Grants

Date of this notice: October 21, 2024

Application Deadline: 5:00PM on December 20, 2024

**Purpose: Description of the function of the program and reason why it was created:** These grant funds, supported through the North Carolina General Assembly, are for assuring access to primary and preventive care to meet the health needs of vulnerable, underserved and medically indigent patients, with emphasis on providing primary and preventive medical services to uninsured or medically indigent patients. An important component of this work is to strengthen the safety net through increased levels of collaboration and integration of services to meet and sustain the needs of those served more effectively. When an eligible primary care medical home safety net organization provides integrated care, grant funding may also support dental, pharmacy, maternal, and behavioral health services.

Maximum Award Amount: Applicants may request up to \$150,000 per year of the grant.

**Funding Availability:** Funding requests are contingent upon availability of program funding. The highest scoring applicants will receive a three-year award based on applicant scores. ORH anticipates that approximately 33 applicants will receive three-year funding. Successful applicants will be required to attend a grant award workshop.

Proposed Project Period or Contract Term: State Fiscal Year 2026: July 1, 2025 – June 30, 2026

Deadline for Submission: December 20, 2024

Grant applications must be received electronically using the on-line application link provided by the Office of Rural Health. All applications are due by 5:00 PM on December 20, 2024. Only electronic applications will be accepted. Incomplete applications, or applications not completed in accordance with the following instructions, will not be reviewed.

#### Opportunity to Participate in Research on HPV Vaccinations in Rural NC

UNC Professor of Family Medicine Dr. Nadja Vielot is conducting NIH-funded research on adolescent HPV vaccination in rural NC. She is looking to recruit four (4) family practice or pediatric clinics that predominantly serve patients living in rural areas. Selected clinics would participate in a four-year project and could earn up to \$10,000 in compensation.

## Promoting Early ACtion against HPV (PEACH) Did you know that...

- ...rural North Carolinians are at increased risk for cervical and other HPV cancers?
- ...HPV vaccination is FDA approved for children as young as age 9?
- ...recommending HPV vaccination at age 9 versus age 11 leads to higher vaccination rates?

PEACH (IRB# 23-3074) is a four-year study to evaluate the benefits of age-9 HPV vaccination. We are seeking four rural NC clinics to participate in the following activities:

- Year 1: Identify a vaccine "Champion" to help the research team develop an intervention plan.
- Year 2: Assist in recruiting patient caregivers for interviews about HPV vaccine acceptability
- Years 3-4: All clinics provide baseline and endline HPV vaccination rates. Two randomly selected clinics will attend a training session on the intervention, implement the intervention, and provide baseline and endline feedback on the intervention.

Clinics and Champions will receive up to \$10,000 for participating in all phases of the project. For more information, click <a href="https://example.com/here">here</a>.
