In the ever-evolving landscape of healthcare, ORH recognizes the paramount importance of internal continuity and collaboration. One strategic initiative that is central to our mission is our Service Area Teams (SATs). SATs are designed to build connections, identify collaborative opportunities, and cultivate new partnerships across our state.

SATs are comprised of members from all programs within ORH including Community Health, Medication Assistance, Rural Health Operations, Farmworker Health, Placement Services, Health Information Technology and Telehealth, Analytics & Innovations, and Business & Contracts.

SATs are divided by Medicaid Region and are grouped as follows:

Regions 1 & 2: Western Service Area Team

Regions 3 & 5: South Central Service Area Team

Regions 4 & 6: Eastern Service Area Team

To address pressing healthcare needs in Madison County, a Community Health Worker (CHW) program has been established at Hot Springs Health Program through MAHEC (Mountain Area Health Education Center), with funding provided by Dogwood Health Trust. Spearheaded by the dedicated efforts of Jacque Ballard, a full-time CHW, the program's focus revolves around addressing the social drivers of health and meeting people where they are.

Jacque's role extends beyond traditional healthcare boundaries. She serves as a lifeline for



individuals in need, offering a comprehensive array of support services. From facilitating access to medication delivery to arranging for essential supplies like shower seats, Jacque ensures that patients receive the care they deserve. Beyond her professional duties, Jacque's presence and reputation in the community is one of compassion and reliability. Patients not only benefit from her expertise but also find solace in her genuine care and concern. Whether it's conducting community walks, delivering

meals, or advocating for housing for the unhoused, Jacque's impact resonates deeply within the community. Her accessibility and willingness to go above and beyond underscore her status as a trusted figure at Hot Springs Health Program and in Madison County.

Teresa Strom, Chief Executive Officer of Hot Springs Health Program, shared the following about the program and the organization's efforts to address the holistic needs of the community, "Jacque embodies the essence of community-centered healthcare. Oftentimes, you'll find her driving the most rural of mountain roads to meet folks in their homes. We have seen great success with the program and know that Jacque is the best person for the job. In addition to these efforts, our organization also participates in collaborative initiatives with the local health department and the Madison County Health Consortium, where we all play a pivotal role in addressing the health of our entire community."

ORH applauds innovative approaches like those taking place in Hot Springs to address the health needs of our rural and underserved communities.



ORH is thrilled to share the success of new State
Designated Rural Health Center, Community Care Clinic
of Franklin, for its efforts to enhance healthcare
accessibility in Macon County. Thanks to a recent federal
appropriation, the organization is ready to acquire a new
building, marking a pivotal step in their journey.
Community Care Clinic of Franklin is currently in
discussions to purchase a building and anticipates
finalizing the purchase and move by Fall 2024. This
development couldn't come at a better time, as the

demand for health care services continues to increase, with approximately ten (10) new patients joining the practice each month.

Despite facing limitations, the organization remains committed to expanding their offerings. While their focus has primarily been on evening clinics, the new space opens doors for expanded daytime hours, integrated behavioral health services, and more. Executive Director Cindy O'Boyle credits her outreach to the legislature in receiving the much-needed funding —thanks in part to the advocacy of Representative Cawthorn, who spearheaded a direct appropriation of \$575,000 for the purchase.

This financial boost will enable the organization in furthering their mission of serving their rural and underserved community while addressing critical social drivers of health needs such as access to transportation. Cindy shared the following on the news of appropriation, "At the heart of our clinic lies a dedication to patient care, and with a dedicated team, we're poised to not only go - but grow together with our community. As we embark on this journey, we're excited for the positive impact this will bring to Macon County, increasing access to care and bolstering support for those in need."

Eastern SAT News and Highlights



The North Carolina Formerly Incarcerated Transition Program (NC FIT) celebrated five years of serving people coming from incarceration and connecting them to essential health services.

NC FIT hires people who are formerly incarcerated and specially trains them as Community Health Workers (CHWs) to support people post-release. The CHWs are embedded in primary care medical homes in six of our most populous counties and have enrolled more than 1,000 people, supporting over \$360,000 of medical care at the partner clinics.

<u>Provider Recruitment and Placement Program</u> provides recruitment efforts for medical, dental and psychiatric health professionals to North Carolina's rural and underserved areas and offers incentives to eligible providers.
