Program Name: In-Home Family Child-Care Program

Purpose of the RFA: Through this Request for Application the Division seeks to create a pilot program to retain and build a new in-home child care programs across the state and to build program quality through business, operational professional development and mentorship.

Description: Low-income families and vulnerable populations may be most affected by the lack of available family child care. North Carolina is committed to families having a mixed delivery early care and learning system including equitable access to family child care providers. The North Carolina Department of Health and Human Services and Division of Child Development and Early Education seeks an entity to establish a pilot program that provides business, financial assistance, professional development and mentorship in creating new child care homes and sustaining existing in-home child care programs in this state.

Funding Availability: Up to \$525,000 is available for the *In-Home Family Child Care Program* from July 1, 2024 – June 30, 2025. A single award will be made used for this program and *one* award will be funded through this announcement.

Applicant Eligibility:

This RFA is open to state agencies and universities, public, for profit, and private nonprofit organizations with a current 501(c)(3) standing who can demonstrate their capacity to manage Federal/State grant funds and programs at an intensive level in collaboration with multiple partners through satisfactory audit reports; education, experience, and expertise of key personnel; and demonstrated support for the proposal from the applicant's organization. Applicants must have knowledge of the NC family childcare home requirements, demonstrate, and provide examples of their strategy to create a pilot program for in-home child care programs. Applicants must establish business and financial assistance in creating new in-home child care programs and sustaining existing programs. In conclusion applicants must work effectively with various state and local agencies. Previous applicants must re-apply to be considered for this funding.
