Facility Application(s)		A green approval checkmark will be present upon enrolling in the new year. All institutions must review and update all Facility Applications. Enter new monitoring dates and ensure the monitoring dates match the dates on the Monitoring Plan. Click on the Certification (after #48) and click save. Facility Applications will then no longer have a green approval checkmark.
