### FOOD INSECURITY IS A CRITICAL CHALLENGE IN NORTH CAROLINA



North Carolina children face food insecurity or chronic hunger<sup>1</sup>




of North Carolina children eligible for free or reducedprice meals at school<sup>1</sup>

# Causes of Food Insecurity During Summer

- Many students lose access to school meals during the summer months
- Lack of access to affordable supermarkets and grocery stores
- Dependency on transportation to summer meal sites

### Impact to Children

- Reliance on schools to provide meals, limiting summer access to nutritious food and impacting children's health
- Adverse childhood development outcomes, including heightened stress and worse academic performance<sup>3</sup>

# PANDEMIC EBT (P-EBT) PROVIDED CRITICAL FOOD ASSISTANCE DURING THE SCHOOL YEAR, BUT THE TEMPORARY PROGRAM ENDED IN 2023



Overview

North Carolina's P-EBT program was a federally funded temporary food assistance program designed to provide grocery-buying benefits to purchase nutritious foods for students and young children during COVID-19. The program began in 2020 but **ended in 2023**.

**Benefits** 

Like FNS EBT, benefits were provided on a pre-loaded card to buy food at authorized EBT retailers, including most grocery stores.

## **Statewide Impact\***



**1.76 million** children served



**93% spend rate**, indicating a critical need for food assistance



**\$2.5 billion** issued in benefits





#### INTRODUCTION TO SUN BUCKS

NCDHHS, in partnership with NC Department of Public Instruction (NCDPI), is expanding its food assistance efforts to become **one of the first states** to administer USDA's **new** summer nutrition program, "SUN Bucks."

## How much in SUN Bucks benefits will be issued?

North Carolina will issue \$120 in benefits per eligible child, which can be used by families to purchase nutritious food.

# Who will be eligible for SUN Bucks?

Students who participate in certain federal assistance programs will be eligible to receive benefits automatically, while other students may apply for SUN Bucks.





#### SUN BUCKS WILL ADDRESS EXISTING ACCESSIBILITY GAPS IN FOOD ASSISTANCE PROGRAMS

SUN Bucks will transform North Carolina's summer food assistance strategy into a **three-pronged approach** that emphasizes **accessibility**.

Currently, North Carolina operates two federally-assisted summer meal programs: the Congregate (Group) Meal Service and the new Non-Congregate Meal Service (Meals To-Go). Accessibility challenges associated with these programs that SUN Bucks will directly address include:




Children may live in areas that do not meet income requirements for summer nutrition meals.



Locating rural sponsors who can provide meals may be challenging due to transportation barriers.



89% of Group Meal Service sites require transportation to access, but only 30% of sites provide transportation.<sup>1</sup>





#### SUN BUCKS 2024 PROGRAM GOAL AND IMPACT

NCDHHS and NCDPI aim to combat hunger among North Carolina's most food insecure children and teens.

NC children will receive benefits to increase access to healthy food choices during the summer months.

# \$120 million\*

in food assistance benefits during the 2024 summer months, feeding children while boosting NC's economy.

#### SUN BUCKS AUTOMATIC ELIGIBILITY

North Carolina students expected to be automatically eligible in 2024

Students may be **automatically eligible** for SUN Bucks if they participate in <u>at least one</u> of the following programs and do **NOT** need to apply:

- 1. National School Lunch Program (NSLP) free or reduced-price (FRP) school meals
- 2. Food and Nutrition Services (FNS, food stamps)
- 3. Work First (Temporary Assistance for Needy Families (TANF), cash assistance)
- 4. Medicaid with household income below 185% of the federal poverty level
- 5. Foster care



# How will families know if one or more of their children are automatically eligible?

Households with one or more children who are automatically eligible should receive an official Eligibility Notice via robocall, text, and email. More details are available on the <u>SUN Bucks webpage</u> (ncdhhs.gov/sunbucks).



#### SCHOOL SEARCH TOOL

A child's eligibility for SUN Bucks is partially impacted by the type of school they attend: National School Lunch Program (NSLP), Community Eligibility Provision (CEP), or neither.


### What are NSLP and CEP?

**NSLP** is a federal program in most public schools and some charter and private nonprofit schools. As part of this program, kids who meet certain criteria can get free meals or meals at a lower price through their school.

**CEP** is part of NSLP and lets schools and education groups in certain places give meals to all students at no cost.

# How can I determine if a school is NSLP, CEP, or neither?

### SUN BUCKS FOR STUDENTS IN FOSTER CARE: 4 THINGS TO KNOW

1

New SUN Bucks cards will be mailed for all students identified as children in foster care to the local county DSS offices with custody of those children in foster care.

2

SUN Bucks cards will be **issued in the student's name**; multiple children will **not** be grouped together on a card.

Foster care social workers are responsible for delivering the following to children in foster care who get SUN Bucks: Eligibility Notice with the new SUN Bucks card, and then later the Benefit Expiration Notice.

4

The **student's foster care social worker** will provide the card and/or assist with transfer of the card to the student's current caretaker, whether that is a family foster home, congregate care setting, or return to biological family.

IMPORTANT: It is imperative that the child's foster care social worker facilitates the transfer of the SUN Bucks card with the child if they change caregivers.



The 2024 SUN Bucks Eligibility Notice should be delivered either electronically or in print to the current caretaker of a student in foster care with their preloaded SUN Bucks card.

# What is the Eligibility Notice?

As required by USDA, the SUN Bucks Eligibility Notice must be delivered (either electronically or printed) to all students who automatically qualify for SUN Bucks and do not need to apply. The Notice includes important information about how to activate a SUN Bucks card, what can be bought with these benefits, and where to go for more information.

# Where may I find the Eligibility Notice?

The Eligibility Notice will be shared electronically with DSS offices. Please deliver to the current caretaker of a student in foster care with their preloaded SUN Bucks card accordingly. Foster care social workers may either print and deliver the notice in-person or share it electronically.







Dear Parent / Guardian:

You are receiving this notice because one or more children in your household have qualified for a new federal food assistance program called SUN Bucks, which helps families buy groceries during the summer when school is out. The qualifying child(ren) will automatically be enrolled in the program, so you do not need to apply. Please note that each child is evaluated for eligibility individually, and not all children in your household may be eligible. Visit www.ncdhhs.gov/sunbucks for information on what qualifies a child for SUN Bucks.

You will receive a one-time \$120 benefit for each eligible child on a card that you can use to buy nutritious food at grocery stores, farmers markets, and other EBT-authorized retailers. If you receive more than \$120 per eligible child in your household, do not use the benefits, and contact the SUN Bucks call center at 1-866-719-0141 as soon as possible.

If you have an active Food and Nutrition Services (FNS, food stamps) case, your SUN Bucks benefits will be loaded on your existing card. If you do not have an active FNS case, you will be mailed a SUN Bucks card.

- If you have Work First (TANF, cash assistance), Cherokee Tribal Food Distribution Program (CTFDP), or Medicaid: Your card will be mailed to the address associated with those benefits.
- If you do not get FNS, TANF, CTFDP, or Medicaid, but your child is approved to get Free or Reduced-Price meals
  at school: Your card will be mailed to the address on file with your child's school.
- If you are in foster care: Your card will be mailed to your DSS office, and your caseworker will help get it to you.
   Note: Not all CEP school children will be eligible, and some may need to apply. Visit <a href="www.ncdhhs.gov/sunbucks">www.ncdhhs.gov/sunbucks</a> for information.

SUN Bucks benefits will begin to go out in June, but children will see their benefits throughout the summer once determined eligible. SUN Bucks cards will be mailed as quickly as possible between June and August. Children whose benefits are attached to active FNS cards will see their SUN Bucks benefits available in their FNS accounts within 10 days of issuance. Benefits expire 122 days after issuance, so make sure to use your benefits during the summer. Receiving SUN Bucks will not affect children or familier immirration status.

How to <u>Activate a New Card</u> OR Order a New Card if you <u>Have Lost or Destroyed</u> Your SUN Bucks Card:
The card works just like a debit card. Before using your card, you must first activate it and select a Personal Identification
Number (PIN). There are three ways to activate your card, check your balance and replace your card:

- 1. Visit www.ebtEDGE.com. Under "EBT Cardholder," click on "More Information." Login or Register here.
- 2. Download and use the ebtEDGE mobile app (can be downloaded on Google Play or Apple Store).
- Call 1-888-622-7328 and follow the prompts.

IMPORTANT: Your PIN activation code will be the date of birth (DOB) of a child in your household. Try the DOB for each student in your household, starting with the youngest. Enter the DOB using two digits for the month, two digits for the day, and four digits for the year. For example, if the date of birth is June 1, 2008, you would enter 06012008.



#### FOSTER CARE SCENARIO EXAMPLE #1



# Is Ray eligible for SUN Bucks this summer?

YES! Ray is automatically eligible for SUN Bucks because he is enrolled in an NSLP school and in foster care, which is one of the programs that makes a child automatically eligible. Ray does <u>not</u> need to apply for SUN Bucks in 2024.

# How will Ray receive his SUN Bucks benefits?

The SUN Bucks card for Ray will be mailed to the **Mecklenburg County DSS Office**. Once delivered, the foster care social worker managing Ray's foster care case will deliver his SUN Bucks card – along with the Eligibility Notice – to Ray's current caretaker. If Ray changes caregivers, the social worker must make sure the SUN Bucks card follows Ray to his new placement. Note, even though Ray participates in FNS, his benefits will be loaded onto a **new** SUN Bucks card.

# Is Rayette eligible for SUN Bucks this summer?

eligible for SUN Bucks because she is enrolled in a CEP school and in foster care, which is one of the programs that makes a child automatically eligible.

Rayette does <u>not</u> need to apply for SUN Bucks in 2024.

# How will Rayette receive her SUN Bucks benefits?

The SUN Bucks card for Rayette will be mailed to the **Wake County DSS Office**. Once delivered, the foster care social worker managing Rayette's foster care case should work with **Catawba County** to deliver her SUN Bucks card – along with the Eligibility Notice – to Rayette's current caretaker. If Rayette changes caregivers, the social worker must make sure the SUN Bucks card follows Rayette to her new placement.

# Are Rainbow and Ryan eligible for SUN Bucks this summer?

YES! Both Rainbow and Ryan are automatically eligible for SUN Bucks. While not enrolled in a NSLP or CEP school, they're between the ages of 7-16 years and in foster care, which is one of the programs that makes a child automatically eligible. They do <u>not</u> need to apply.

# How will Rainbow and Ryan receive their SUN Bucks benefits?

**Two, separate** SUN Bucks cards – one for Rainbow and one for Ryan – will be mailed to the **Alamance County DSS Office**. Once delivered, the foster care social worker(s) managing Rainbow and Ryan's foster care cases will deliver the SUN Bucks cards – along with the Eligibility Notices – to the current caretaker(s) for Rainbow and Ray. If either child changes caregivers, the social worker must make sure the SUN Bucks card follows that child to their new placement.



#### SUN BUCKS FOR STUDENTS IN FOSTER CARE: EXPIRATION NOTICE

The 2024 SUN Bucks Expiration Notice should be delivered to the current caretaker of a student in foster care no less than 30-days ahead of their benefits expiration date.

# What is the Expiration Notice?

As required by USDA, the SUN Bucks Expiration Notice must be delivered (either electronically or via print) to all students who received SUN Bucks no less than 30 days ahead of their benefits expiring. The Notice includes important information about managing a SUN Bucks account and where to go for more information.

# How do I know when to deliver the Expiration Notice?

Counties will receive lists of students in foster care who have received SUN Bucks and their expiration dates. Based on this report, it is the responsibility of the county and foster care social worker to deliver the Expiration Notice to the current caretaker of a student in foster care at least 30-days before the student's benefits expire. **The Expiration Notice will be shared with DSS offices electronically.** 

SUN Bucks benefits expire 122 days after the benefits are available, not the date that the card was activated.
