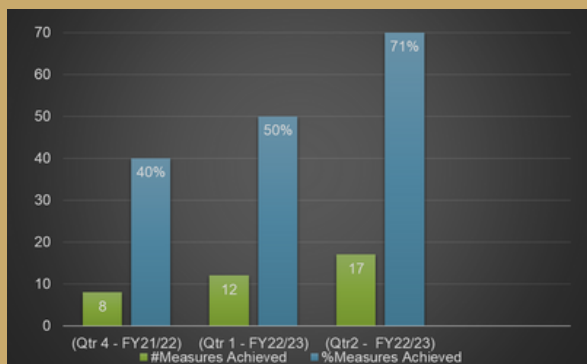
HOUSING

The FY22/23 Quarter 2 results of the TCL Incentive Plan are here!

We are pleased to announce that our progress continued with an impressive 71% of the overall measures achieved in Quarter 2! The MCOs' were able to accomplish an average of three out of the four defined measures required.

A special recognition goes to Partners for accomplishing all four measures in Quarter2! The significant actions they took to enhance their performance in housing were realized in their results. Congratulations Partners!

On average, the MCOs have improved each quarter. We appreciate all the strides they have made to increase performance and look forward to their continued progress and growth. QUALITY ASSURANCE

The TCL Performance Data Dashboard developed and released by Mathematica in SFY 2022 is a crucial component of the State's TCL Quality Assurance and Performance Improvement System that brings together more than six years of data from diverse DHHS systems and sources into a single platform. The dashboard includes:

- Defined measures from a comprehensive set of 200
- Centralized monitoring of participant outcomes
- Program operations and performance
- Settlement agreement requirements related to housing, diversion, in-reach, transition and discharge, services, community integration, and quality of life.

The dashboard consists of quarterly data refreshes and advanced features such as the option to view measures for population subsets. This new tool enhances the State's ability to detect changes in performance over time, identify differences in participant outcomes by region, and analyze and understand the impacts of TCL supports and services for the individuals we serve.

Person Centered Planning

- DMHDDSAS has developed a new guidance document for the Person-Centered Planning (PCP) process. This new guidance focuses on self-advocacy and the individual's desire for change and creates a new emphasis on self-determination and choice. As part of this initiative, we are offering free trainings on Person-Centered Planning that meet the requirements for service providers responsible for developing a PCP. Focus Groups

- Our next step in this process is to develop a statewide implementation plan for the new PCP guidance. We are scheduling focus groups to help determine the next steps for implementation.
- The focus groups are for LME/MCO leaders responsible for utilization reviews and clinical monitoring of services.
- We currently have the following sessions scheduled:

- Expanded ACT services through the addition of 12 new ACT teams serving (as of 12/2022) 5,400 individuals.
